## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Caroline County Board of Education – Member Compensation – Increase**

3 FOR the purpose of increasing the annual compensation of the president and voting  
4 members of the Caroline County Board of Education; and generally relating to the  
5 compensation of the members of the Caroline County Board of Education.

6 BY repealing and reenacting, without amendments,  
7 Article – Education

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
17 That the Laws of Maryland read as follows:

18 **Article – Education**

19 3–3A–02.

1 (a) The Caroline County Board of Education consists of:

2 (1) Three elected members;

3 (2) Two appointed members; and

4 (3) Two nonvoting student members.

5 3-3A-05.

6 (a) The president of the county board is entitled to receive [\$4,000] **\$6,000**  
7 annually as compensation, and the other voting members are entitled to receive [\$3,500]  
8 **\$5,500** each annually as compensation.

9 SECTION 2. AND BE IT FURTHER ENACTED, That, in accordance with Article  
10 III, § 35 of the Maryland Constitution, this Act may not be construed to extend or apply to  
11 the salary or compensation of the president or other voting members of the Caroline County  
12 Board of Education while serving in a term of office beginning before the effective date of  
13 this Act, but the provisions of this Act concerning the salary or compensation of the  
14 president and other voting members of the Caroline County Board of Education shall take  
15 effect at the beginning of the next following term of office. This limitation does not apply to  
16 an individual appointed or elected after the effective date of this Act to fill out an unexpired  
17 term.

18 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
19 1, 2026.
