AMENDMENTS TO HOUSE BILL 115  
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in the sponsor line, strike “**Delegate Wilkins**” and substitute “**Delegates Wilkins, Wells, Sample–Hughes, Lehman, and Crutchfield**”; in line 4, after the first “of” insert “requiring, on or before a certain date, the State Board of Elections and the Department of Public Safety and Correctional Services to jointly develop and implement certain procedures and a certain electronic transmission process for the restoration of voter registration for individuals released from incarceration at a State correctional facility;”; in the same line, strike “of Public Safety and Correctional Services”; in line 6, strike “Board of Elections”; in line 7, strike “automatically” and substitute “promptly”; strike beginning with “voters” in line 9 down through “Department” in line 10 and substitute “the voter registration agency through which a formerly incarcerated voter has registered”; and strike beginning with “under” in line 10 down through “Act” in line 11 and substitute “to the public”.

AMENDMENT NO. 2

On page 2, after line 26, insert:

**“(B) ON OR BEFORE JANUARY 1, 2028, THE STATE BOARD AND THE DEPARTMENT OF PUBLIC SAFETY AND CORRECTIONAL SERVICES JOINTLY SHALL DEVELOP AND IMPLEMENT PROCEDURES AND AN ELECTRONIC TRANSMISSION PROCESS THAT COMPLY WITH THIS SECTION FOR THE RESTORATION OF VOTER REGISTRATION FOR INDIVIDUALS RELEASED FROM INCARCERATION AT A STATE CORRECTIONAL FACILITY.”;**

in line 27, strike “(B)” and substitute “(C)”; in the same line, strike “WEEKLY” and substitute “MONTHLY”; and in line 29, strike “NAME AND NEW RESIDENTIAL ADDRESS OF” and substitute “FOLLOWING INFORMATION FOR”.

On page 3, in line 2, strike “WEEK” and substitute “MONTH”:

**(1) THE INDIVIDUAL’S FULL NAME;**

**(2) THE INDIVIDUAL’S DATE OF BIRTH;**

**(3) THE LAST FOUR DIGITS OF THE INDIVIDUAL’S SOCIAL SECURITY NUMBER, DRIVER’S LICENSE NUMBER, OR STATE-ISSUED IDENTIFICATION CARD NUMBER;**

**(4) THE DATE THE INDIVIDUAL WAS RELEASED FROM INCARCERATION; AND**

**(5) THE INDIVIDUAL’S NEW RESIDENTIAL ADDRESS”;**

in lines 3, 7, 11, and 23, strike “(C)”, “(D)”, “(E)”, and “(F)”, respectively, and substitute “(D)”, “(E)”, “(F)”, and “(G)”, respectively; in line 3, strike “(B)” and substitute “(C)”; in line 7, strike “AUTOMATICALLY” and substitute “PROMPTLY”; in line 8, strike “(C)” and substitute “(D)”; in line 13, strike “(D)” and substitute “(E)”; and strike beginning with the first “THE” in line 23 down through “SECTION” in line 25 and substitute “§ 3–506 OF THIS TITLE AND THE PUBLIC INFORMATION ACT, THE IDENTITY OF THE VOTER REGISTRATION AGENCY THROUGH WHICH A FORMERLY INCARCERATED VOTER HAS REGISTERED UNDER THIS SECTION”.
