### CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Family Law – Children in Out-of-Home Placement – Voluntary Placement**  
3 **Agreements**

4 FOR the purpose of altering provisions relating to children who are placed in an  
5 out-of-home placement by a local department of social services under a voluntary  
6 placement agreement; ~~altering the duties of the Workgroup on Children in~~  
7 ~~Unlicensed Settings and Pediatric Hospital Overstays~~; requiring the Department of  
8 Human Services and the Maryland Department of Health to jointly submit a certain  
9 report concerning children who are placed in an out-of-home placement under a  
10 voluntary placement agreement; *establishing that certain child support due to the*  
11 *State before the effective date of this Act shall be unenforceable and uncollectable*; and  
12 generally relating to children in out-of-home placement and voluntary placement  
13 agreements.

23 ~~WHEREAS, Maryland’s Voluntary Placement Agreement system was designed to  
 24 allow families to access out-of-home treatment for children with serious mental illness or  
 25 developmental disabilities without permanently surrendering custody; and~~

26 ~~WHEREAS, Current statutory and administrative procedures have resulted in  
 27 significant delays in placement, often exceeding 60 to 90 days, contributing to extended  
 28 pediatric inpatient stays, emergency department boarding, and unnecessary family  
 29 distress; and~~

30 ~~WHEREAS, The local care team process, while intended to coordinate interagency  
 31 services, has proven largely ineffective in facilitating timely or appropriate supports, and  
 32 its required involvement has become a systemic bottleneck; and~~

33 ~~WHEREAS, The 2022 General Assembly enacted legislation intended to streamline  
 34 access to psychiatric residential treatment for Medicaid-eligible children by clarifying the  
 35 authority of local behavioral health authorities to approve the educational component of  
 36 residential placements; however, implementation challenges and unresolved interagency~~

~~roles have limited the realization of that intent, perpetuating delays and inequities for families seeking timely psychiatric residential treatment; and~~

~~WHEREAS, The General Assembly recognizes the urgent need to codify timelines, clarify agency accountability, and eliminate duplicative procedural barriers to ensure that children in crisis receive timely, clinically appropriate care; now, therefore,~~

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
That the Laws of Maryland read as follows:

### Article – Family Law

5–525.

(a) (1) In this section, “disability” means:

(i) a physical or mental impairment that substantially limits one or more of an individual’s major life activities;

(ii) a record of having a physical or mental impairment that substantially limits one or more of an individual’s major life activities; or

(iii) being regarded as having a physical or mental impairment that substantially limits one or more of an individual’s major life activities.

(2) “Disability” shall be construed in accordance with the ADA Amendments Act of 2008, P.L. 110–325.

(b) (1) The Administration shall establish a program of out-of-home placement for minor children:

(i) who are placed in the custody of a local department, for a period of not more than 180 days, by a parent or legal guardian under a voluntary placement agreement;

(ii) who are abused, abandoned, neglected, or dependent, if a juvenile court:

1. has determined that continued residence in the child’s home is contrary to the child’s welfare; and

2. has committed the child to the custody or guardianship of a local department; or

(iii) who, with the approval of the Administration, are placed in an out-of-home placement by a local department under a voluntary placement agreement subject to paragraph (2) of this subsection.

1 (2) (i) A local department may not seek legal **GUARDIANSHIP OR**  
2 custody of a child under a voluntary placement agreement if the child has a developmental  
3 disability or a mental illness and the purpose of the voluntary placement agreement is to  
4 obtain treatment or care related to the child's disability that the parent is unable to provide.

5 (ii) A child described in subparagraph (i) of this paragraph may  
6 remain in an out-of-home placement, **INCLUDING A RESIDENTIAL PLACEMENT**, under  
7 a voluntary placement agreement for more than 180 days if the child's disability  
8 necessitates care or treatment in the out-of-home placement and a juvenile court makes a  
9 finding that continuation of the placement is in the best interests of the child.

10 (iii) Each local department shall designate, from existing staff, a staff  
11 person to administer requests for voluntary placement agreements for children with  
12 developmental disabilities or mental illnesses.

13 **(IV) IF A LOCAL DEPARTMENT RECEIVES A REQUEST FOR A**  
14 **VOLUNTARY PLACEMENT AGREEMENT, THE LOCAL DEPARTMENT SHALL:**

15 **1. WITHIN 5 BUSINESS DAYS AFTER RECEIVING THE**  
16 **REQUEST, SCHEDULE AN ASSESSMENT MEETING WITH THE CHILD'S FAMILY AND**  
17 **TREATING PROVIDER; AND**

18 **2. WITHIN 5 BUSINESS DAYS AFTER THE ASSESSMENT**  
19 **MEETING, ISSUE A WRITTEN ELIGIBILITY DETERMINATION TO THE CHILD'S FAMILY**  
20 **AND REFERRING PROVIDER.**

21 **(V) 1. EACH LOCAL DEPARTMENT SHALL REPORT ANY**  
22 **DELAY IN ASSESSING THE CHILD AND PROVIDING AN ELIGIBILITY DETERMINATION**  
23 **AS REQUIRED UNDER SUBPARAGRAPH (IV) OF THIS PARAGRAPH TO THE**  
24 **ADMINISTRATION, INCLUDING REASONS FOR THE DELAY AND CORRECTIVE**  
25 **ACTIONS TAKEN BY THE LOCAL DEPARTMENT.**

26 **2. NOTHING IN THIS SUBPARAGRAPH MAY BE**  
27 **INTERPRETED TO PREVENT A LOCAL CARE TEAM FROM PROVIDING THE CHILD AND**  
28 **FAMILY WITH ALTERNATIVE OR INTERIM SERVICES.**

29 **[(iv)] (VI)** Each local department shall report annually to the  
30 Administration on the number of requests for voluntary placement agreements for children  
31 with developmental disabilities or mental illnesses that have been received, the outcome of  
32 each request, and the reason for each denial.

33 **[(v)]** On receipt of a request for a voluntary placement agreement for  
34 a child with a developmental disability or a mental illness, a local department shall discuss  
35 the child's case at the next meeting of the local care team for the purpose of determining

1 whether any alternative or interim services for the child and family may be provided by  
2 any agency.]

3 (3) (i) The Administration shall establish a program of out-of-home  
4 placement for former CINAs:

5 1. whose commitment to a local department was rescinded  
6 after the individuals reached the age of 18 years but before the individuals reached the age  
7 of 20 years and 6 months; and

8 2. who did not exit foster care due to reunification, adoption,  
9 guardianship, marriage, or uniformed services duty.

10 (ii) The Administration shall adopt regulations that include  
11 eligibility requirements in accordance with federal law and regulations for providing  
12 assistance to individuals at least 18 years old.

13 (iii) A local department may not seek legal custody of a former CINA  
14 under a voluntary placement agreement.

15 (iv) A former CINA described in subparagraph (i) of this paragraph  
16 may remain in an out-of-home placement under a voluntary placement agreement for  
17 more than 180 days if the former CINA continues to comply with the voluntary placement  
18 agreement and a juvenile court makes a finding that the continuation of the placement is  
19 in the best interests of the former CINA.

20 (v) 1. A local department shall advise a child, in writing, before  
21 emancipation of the right to reenter care and the procedures for reentering care under this  
22 paragraph.

23 2. If a local department has knowledge that a former CINA  
24 described in subparagraph (i) of this paragraph is homeless, as defined in 42 U.S.C. §  
25 11434a, including by obtaining information regarding the former CINA's homelessness in  
26 an application for public assistance or through contact between the former CINA and a  
27 caseworker, the local department shall contact the former CINA and advise the former  
28 CINA of the right to reenter care and procedures for reentering care under this paragraph.

29 (c) In establishing the out-of-home placement program the Administration shall:

30 (1) provide time-limited family reunification services to a child placed in  
31 an out-of-home placement and to the parents or guardian of the child, in order to facilitate  
32 the child's safe and appropriate reunification within a timely manner;

33 (2) concurrently develop and implement a permanency plan that is in the  
34 best interests of the child; and

1           (3)   **IN CONSULTATION WITH THE MARYLAND DEPARTMENT OF**  
 2 **HEALTH**, provide training on an annual basis for the staff at each local department who  
 3 administer requests for voluntary placement agreements for children with developmental  
 4 disabilities or mental illnesses under subsection (b) of this section, **INCLUDING TRAINING**  
 5 **ON:**

6                   **(I)    TIMELINE AND PROCEDURAL COMPLIANCE;**

7                   **(II)   TRAUMA–INFORMED FAMILY ENGAGEMENT; AND**

8                   **(III)   INTERAGENCY COORDINATION.**

9           (d)   (1)   The local department shall provide 24–hour a day care and supportive  
 10 services for a child who is committed to its custody or guardianship in an out–of–home  
 11 placement on a short–term basis or placed in accordance with a voluntary placement  
 12 agreement.

13                   (2)   (i)   A child may not be committed to the custody or guardianship of  
 14 a local department and placed in an out–of–home placement solely because the child’s  
 15 parent or guardian lacks shelter or has a disability or solely because the child’s parents are  
 16 financially unable to provide treatment or care for a child with a developmental disability  
 17 or mental illness.

18                           (ii)   The local department shall make appropriate referrals to  
 19 emergency shelter services and other services for the homeless family with a child which  
 20 lacks shelter.

21           (e)   (1)   Unless a court orders that reasonable efforts are not required under §  
 22 3–812 of the Courts Article or § 5–323 of this title, reasonable efforts shall be made to  
 23 preserve and reunify families:

24                           (i)   prior to the placement of a child in an out–of–home placement,  
 25 to prevent or eliminate the need for removing the child from the child’s home; and

26                           (ii)   to make it possible for a child to safely return to the child’s home.

27                   (2)   In determining the reasonable efforts to be made and in making the  
 28 reasonable efforts described under paragraph (1) of this subsection[.]:

29                           **(I)    A CHILD’S PARENT OR LEGAL GUARDIAN NEED NOT**  
 30 **EXHAUST ALL HOME– AND COMMUNITY–BASED SERVICES; AND**

31                           **(II)   the child’s safety and health shall be the primary concern.**

1 (3) Reasonable efforts to place a child for adoption or with a legal guardian  
2 may be made concurrently with the reasonable efforts described under paragraph (1) of this  
3 subsection.

4 (4) If continuation of reasonable efforts to reunify the child with the child's  
5 parents or guardian is determined to be inconsistent with the permanency plan for the  
6 child:

7 (i) reasonable efforts shall be made to place the child in a timely  
8 manner in accordance with the permanency plan, including consideration of both in-State  
9 and out-of-state placements, and to complete the steps to finalize the permanent  
10 placement of the child; and

11 (ii) in a case in which the parent of the child is receiving treatment  
12 in a residential substance use disorder treatment program with beds or services for  
13 patients' children and the child is in the presence of the child's parent for the duration of  
14 the child's parent's treatment, the local department shall file a report with the court that  
15 explains:

16 1. why the child was not placed with the parent;

17 2. any efforts the local department has made toward  
18 placement of the child; and

19 3. any difficulties with placing the child with the parent.

20 **(M) (1) A PARENT OR LEGAL GUARDIAN WHO ENTERS INTO A VOLUNTARY  
21 PLACEMENT AGREEMENT UNDER THIS SECTION RETAINS ALL LEGAL AND  
22 EDUCATIONAL DECISION-MAKING RIGHTS, UNLESS OTHERWISE AGREED.**

23 **(2) A LOCAL DEPARTMENT MAY NOT REQUIRE A PARENT OR LEGAL  
24 GUARDIAN TO RELINQUISH CUSTODY OR GUARDIANSHIP OF A CHILD TO ACCESS  
25 SERVICES.**

26 **(N) (1) A LOCAL DEPARTMENT SHALL NOTIFY THE PARENT OR LEGAL  
27 GUARDIAN OF A CHILD SUBJECT TO A VOLUNTARY PLACEMENT AGREEMENT OF THE  
28 RIGHT TO PETITION THE COURT FOR A MODIFICATION OF AN EXISTING CHILD  
29 SUPPORT OBLIGATION.**
