## CHAPTER \_\_\_\_\_

2 **State Procurement and Personnel – Liquidated Damages Documentation**  
3 **Requirements and State Fiscal Leadership Capacity**

4 FOR the purpose of requiring units of State government to provide certain documentation  
5 to the Board of Public Works and the Joint Audit and Evaluation Committee if the  
6 unit decides not to pursue certain liquidated damages; authorizing the Secretary of  
7 Budget and Management to ~~grant a certain exemption to the State pay plan under~~  
8 ~~certain circumstances~~ set the pay scale for certain chief financial officer positions in  
9 order to assist with recruitment and retention; requiring ~~certain appointing~~  
10 ~~authorities to select~~ the Secretary to establish certain minimum qualifications for  
11 chief financial officers that ~~meet~~ consider certain ~~requirements;~~ qualifications;  
12 requiring the Department of Budget and Management to adopt certain regulations  
13 on or before a certain date; requiring certain chief financial officers to provide to the  
14 Office of the Comptroller certain financial information at the close of the fiscal year

28 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

29 That the Laws of Maryland read as follows:

30 **Article – State Finance and Procurement**

32 (a) In this Division II the following words have the meanings indicated unless:

33 (1) the context clearly requires a different meaning; or

34 (2) a different definition is provided for a particular title or provision.

35 (d) “Board” means the Board of Public Works.

1           (aa) (1) “Unit” means an officer or other entity that is in the Executive Branch  
2 of the State government and is authorized by law to enter into a procurement contract.

3                   (2) “Unit” does not include:

4                           (i) a bistate, multistate, bicounty, or multicounty governmental  
5 agency; or

6                           (ii) a special tax district, sanitary district, drainage district, soil  
7 conservation district, water supply district, or other political subdivision of the State.

9           (a) In this section, “liquidated damages” means damages in an amount  
10 designated by the parties to a contract that the injured party is eligible to collect as  
11 compensation for a specific breach of the contract.

12           (d) A unit shall obtain the approval of the head of the unit if the unit decides not  
13 to include in a contract a liquidated damages clause specified under § 13–218(a)(4) of this  
14 article.

15           (e) **[(1)]** This subsection applies only to procurements valued at \$5,000,000 or  
16 more.

17                   **[(2)]** If a unit decides not to pursue liquidated damages when a specified  
18 breach associated with a liquidated damages provision has occurred, the unit shall:

19                           **[(i)] (1)** obtain the approval of the decision by the head of the unit;  
20 [and]

21                           **[(ii)] (2)** maintain documentation on the reason the unit decided  
22 not to pursue liquidated damages; AND

23                           **(3) PROVIDE DOCUMENTATION TO THE BOARD AND THE JOINT**  
24 **AUDIT AND EVALUATION COMMITTEE ON THE REASON THAT THE UNIT INTENDS**  
25 **NOT TO PURSUE LIQUIDATED DAMAGES.**
