AMENDMENTS TO HOUSE BILL 1532, AS AMENDED

AMENDMENT NO. 1

On page 1 of the Environment and Transportation Committee Amendments (HB1532/823929/1), in Amendment No. 1, strike beginning with “moving” in line 8 down through “dashboards;” in line 13; and strike beginning with “altering” in line 14 down through “requirements;” in line 18.

On page 2 of the Environment and Transportation Committee Amendments, in Amendment No. 1, strike beginning with “authorizing” in line 1 down through “circumstances;” in line 2; strike beginning with “altering” in line 4 down through “contract;” in line 11; strike beginning with “requiring” in line 14 down through “auctions;” in line 15; strike beginning with “prohibiting” in line 18 down through “rates;” in line 19; strike beginning with “limiting” in line 20 down through “companies;” in line 21; and strike beginning with “requiring” in line 24 down through “Program;” in line 29 and substitute “altering and adding certain reporting requirements;”.

On pages 3 and 4 of the Environment and Transportation Committee Amendments, in Amendment No. 1, strike beginning with “BY” in line 1 on page 3 down through “Supplement)” in line 20 on page 4.

On page 4 of the Environment and Transportation Committee Amendments, in Amendment No. 1, strike line 23 in its entirety and substitute:

“Section 4-203.1 and 7-306.4”.

On page 5 of the Environment and Transportation Committee Amendments, in Amendment No. 1, strike beginning with “4-212,” in line 1 down through “7-208,” in line 2 and substitute “4-213,”; strike in their entirety lines 3 and 4, and substitute “and”

(j), ~~7-1006, and 7-1007~~"; in line 9, strike "~~7-207(g), 7-216.1(a)(1) and (5) and (c),~~"; and strike line 10 in its entirety and substitute "(7)".

On pages 5 and 6 of the Environment and Transportation Committee Amendments, in Amendment No. 1, strike in their entirety the lines beginning with line 13 on page 5 through line 16 on page 6, inclusive.

AMENDMENT NO. 2

On pages 6 through 28 of the Environment and Transportation Committee Amendments, in Amendment No. 2, strike beginning with "SECTION" line 2 on page 6 down through "ARTICLE." in line 7 on page 28 and substitute:

"SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

Article – Public Utilities".

On pages 30 through 60 of the Environment and Transportation Committee Amendments, in Amendment No. 2, strike in their entirety the lines beginning with line 17 on page 30 through line 11 on page 60, inclusive.

On pages 75 through 82 of the Environment and Transportation Committee Amendments, in Amendment No. 2, strike in their entirety the lines beginning with line 18 on page 75 through line 24 on page 82, inclusive.

In the Chair of the Environment and Transportation Committee's Amendment (HB 1532/513928/1), in line 19, strike "\$50,000,000".

On pages 85 through 105 of the Environment and Transportation Committee Amendments, in Amendment No. 2, strike in their entirety the lines beginning with line 5 on page 85 through line 10 on page 105, inclusive.

On page 105 of the Environment and Transportation Committee Amendments, in line 11 of Amendment No. 2, strike "4." and substitute "2.".

On pages 106 through 109 of the Environment and Transportation Committee Amendments, in Amendment No. 2, strike in their entirety the lines beginning with line 20 on page 106 through line 25 on page 109, inclusive.

On pages 115 and 116 of the Environment and Transportation Committee Amendments, in Amendment No. 2, strike in their entirety the lines beginning with line 21 on page 115 through line 14 on page 116, inclusive.

On page 120 of the Environment and Transportation Committee Amendments, in Amendment No. 2, strike in their entirety lines 1 through 5, inclusive; and in line 6, strike "6." and substitute "3.".

On page 122 of the Environment and Transportation Committee Amendments, in line 17 of Amendment No. 2, strike "7." and substitute "4.".

On page 123 of the Environment and Transportation Committee Amendments, in Amendment No. 2, strike beginning with the colon in line 7 down through "(2)" in line 10.

On pages 125 through 127 of the Environment and Transportation Committee Amendments, in Amendment No. 2, strike in their entirety the lines beginning with line 4 on page 125 through line 15 on page 127, inclusive.

On page 127 of the Environment and Transportation Committee Amendments, in line 16 of Amendment No. 2, strike "11." and substitute "5."; in line 24, strike "12." and substitute "6."; in lines 24 and 25, strike "1, 2, 3, 5, 10, and 11" and substitute "1 and 5"; and in line 26, strike "13." and substitute "7.".

On page 128 of Amendment No. 2, in line 2, strike "12" and substitute "6".
