A BILL ENTITLED

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
That the Laws of Maryland read as follows:

Article – Human Services

7–302.

(a) There is a Maryland Commission on Caregiving in the Department.

7–303.

(a) (1) The Commission consists of the following members:

(i) one member of the Senate of Maryland, appointed by the
President of the Senate;

(ii) one member of the House of Delegates, appointed by the Speaker
of the House; and

(iii) the following members appointed by the Governor:

1. two representatives from the Department of Human
Services;

2. three representatives from the Maryland Department of
Health;

3. one representative from the Department of Aging;

4. one representative from an area agency on aging;

5. one representative from the Department of Disabilities;

6. one representative from the Maryland Respite Care
Coalition;

7. two consumers of respite care services;

8. three family caregivers; [and]

9. three representatives of organizations that provide or
have interest or expertise in respite care services; AND

**10. ONE FAMILY CAREGIVER OF A SERVICE-DISABLED
VETERAN.**

1 (c) A trustee:

2 (1) may not receive compensation as a trustee; but

3 (2) is entitled to reimbursement for expenses under the Standard State
4 Travel Regulations, as provided in the State budget.

5 (d) The Department shall provide staff, supplies, and office space for the Board.

6 9–917.

7 (a) (1) The Commission consists of the following members appointed by the
8 Governor.

9 (2) Of the members:

10 (i) 1 shall be appointed from each of the 8 congressional districts in
11 the State;

12 (ii) 1 shall be a veteran appointed from the State at large;

13 (iii) 1 shall be a woman veteran appointed from the State at large;

14 (iv) 1 shall be a representative of a retired enlisted organization;

15 (v) 1 shall be a veteran of the Iraq or Afghanistan conflict, as defined
16 in § 1–202(a–1) of the Public Safety Article; AND

17 (vi) 1 shall be appointed from a list of individuals submitted to the
18 Governor by each of the following organizations:

19 1. [the American Ex–Prisoners of War, Inc.;

20 2.] the American Legion;

21 [3.] 2. the AMVETS;

22 [4.] 3. the Catholic War Veterans;

23 [5.] 4. the Disabled American Veterans;

24 [6.] 5. the Fleet Reserve Association;

25 [7.] 6. the Jewish War Veterans;

- 1 [8.] 7. the Marine Corps League;
- 2 [9.] 8. the Maryland Military Officers Association of America;
- 3 [10.] 9. the Military Order of the Purple Heart;
- 4 [11.] 10. the Polish Legion of American Veterans;
- 5 [12.] 11. the Veterans of Foreign Wars;
- 6 [13.] 12. the Vietnam Veterans of America;
- 7 [14.] 13. the Korean War Veterans Association, Inc.;
- 8 [15.] 14. the National Association for Black Veterans;
- 9 [16.] 15. the Colonial Chapter of the Paralyzed Veterans of
10 America; [and]
- 11 [17.] 16. the Reserve Organization of America; and
- 12 16. AN ORGANIZATION REPRESENTING MILITARY
13 FAMILIES.

14 [(vii) 1 shall be an honorary nonvoting member appointed from a list
15 of individuals submitted to the Governor by the Pearl Harbor Survivors Association.]

16 (b) Each member must be a resident of the State and a veteran.

17 (c) (1) The term of an appointed member is 5 years.

18 (2) The terms of the appointed members are staggered as required by the
19 terms provided for members of the Commission on October 1, 1984.

20 (3) At the end of a term, a member continues to serve until a successor is
21 appointed and qualifies.

22 (4) A member who is appointed after a term has begun serves only for the
23 rest of the term and until a successor is appointed and qualifies.

24 (5) When an organization is no longer a part of the Commission, the
25 appointment shall terminate at the end of the current member's term.

1 **(6) AN ORGANIZATION'S REPRESENTATIVE SEAT MAY BE REMOVED IF**
2 **THE ORGANIZATION FAILS TO APPOINT A NEW COMMISSIONER FOR 2 CONTINUOUS**
3 **YEARS.**

4 **(7) AN ORGANIZATION MAY BE REMOVED FROM THE COMMISSION IF**
5 **A REPRESENTATIVE FROM THE ORGANIZATION IS NOT RECOMMENDED BY THAT**
6 **ORGANIZATION.**

7 [(d) A new organization may not be eligible for representation on the Commission,
8 by appointment of the Governor, unless it is congressionally chartered.]

9 9-2701.

10 (b) There is a Maryland Youth Advisory Council.

11 (c) (1) The Council consists of:

12 (i) four youths appointed by the President of the Senate;

13 (ii) four youths appointed by the Speaker of the House of Delegates;

14 (iii) four youths appointed by the Governor; and

15 (iv) the following members appointed by the Governor's Office for
16 Children:

17 1. four youths nominated by the local management boards
18 established under § 8-301 of the Human Services Article;

19 2. four youths nominated by the Maryland Association of
20 Student Councils;

21 3. two youths nominated by the University System of
22 Maryland Student Council; [and]

23 4. the following youths nominated by the Student Advisory
24 Council to the Maryland Higher Education Commission:

25 A. one youth who is enrolled in a community college; and

26 B. one youth who is enrolled in a private college or university;

27 **AND**

28 **5. ONE YOUTH WHO HAS AN IMMEDIATE FAMILY**
29 **MEMBER WHO IS A SERVICE MEMBER, APPOINTED BY THE DEPARTMENT OF**
30 **VETERANS AND MILITARY FAMILIES.**

1 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
2 October 1, 2026.
