AMENDMENTS TO HOUSE BILL 299
(Third Reading File Bill)

AMENDMENT NO. 1

On page 1, strike beginning with “prohibiting” in line 4 down through “rates;” in line 11; in line 12, strike “the MFCA,”; and in line 18, after “manner;” insert “requiring the Commissioner to develop a certain training and form language, make the training and form language publicly available on the Maryland Department of Labor’s website, and require certain contractors to take the training;”.

On page 2, strike in their entirety lines 1 through 15, inclusive; in line 18, strike “and”; and in the same line, after “3-913” insert “, and 3-917”.

AMENDMENT NO. 2

On pages 3 through 5, strike in their entirety the lines beginning with line 4 on page 3 through line 26 on page 5, inclusive.

On page 7, in line 4, after “(K)” insert “**(1)**”; in line 6, strike “A VIOLATION” and substitute “**RESTITUTION TO ANY IMPACTED EMPLOYEE WHEN A VIOLATION**”; in line 7, strike “THAT”; and after line 9, insert:

“(2) A SUBCONTRACTOR SHALL INDEMNIFY A GENERAL CONTRACTOR FOR ANY WAGES, DAMAGES, INTEREST, PENALTIES, OR ATTORNEY’S FEES OWED AS A RESULT OF THE SUBCONTRACTOR’S VIOLATION UNLESS INDEMNIFICATION IS PROVIDED FOR IN A CONTRACT BETWEEN THE GENERAL CONTRACTOR AND THE SUBCONTRACTOR.”

On page 10, strike beginning with “**EXCEPT**” in line 4 down through “**TO**” in line 5 and substitute “**TO**”; and in lines 8 and 9, strike “, **TITLE 8 OF THE GENERAL PROVISIONS ARTICLE,**”.

On page 11, strike beginning with “**EXCEPT**” in line 5 down through “**THE**” in line 6 and substitute “**THE**”; and strike in their entirety lines 10 through 18, inclusive.

On page 16, after line 5, insert:

“3-917.

(A) THE COMMISSIONER SHALL:

(1) DEVELOP A TRAINING COURSE ON THE REQUIREMENTS OF THIS SUBTITLE;

(2) MAKE THE TRAINING PUBLICLY AVAILABLE ON THE DEPARTMENT’S WEBSITE; AND

(3) REQUIRE A CONTRACTOR FOUND TO HAVE VIOLATED THIS SUBTITLE TO COMPLETE THE TRAINING.

(B) THE COMMISSIONER SHALL:

(1) DEVELOP FORM LANGUAGE THAT CONTRACTORS MAY USE WHEN ADVISING SUBCONTRACTORS OF THE REQUIREMENTS OF §§ 3-903.1 AND 3-914 OF THIS SUBTITLE; AND

(2) PUBLISH THE FORM LANGUAGE ON THE DEPARTMENT’S WEBSITE.

(C) The Commissioner shall adopt regulations to carry out this subtitle.

On page 20, strike beginning with “**EXCEPT**” in line 29 down through “**TO**” in line 30 and substitute “**TO**”.

On pages 20 and 21, strike beginning with “, **TITLE**” in line 33 on page 20 down through the first “**ARTICLE**” in line 1 on page 21.

On page 21, strike beginning with “**EXCEPT**” in line 23 down through “**THE**” in line 24 and substitute “**THE**”.

On pages 21 and 22, strike in their entirety the lines beginning with line 28 on page 21 through line 5 on page 22, inclusive.

On page 23, in line 31, strike “**EXCEPT AS PROVIDED IN SUBSECTION (D) OF THIS SECTION, TO**” and substitute “**TO**”.

On page 24, in line 3, strike “**TITLE 8 OF THE GENERAL PROVISIONS ARTICLE,**”.

On page 24, strike beginning with “**EXCEPT**” in line 23 down through “**THE**” in line 24 and substitute “**THE**”.

On pages 24 and 25, strike in their entirety the lines beginning with line 27 on page 24 through line 5 on page 25, inclusive.

On page 25, in line 6, strike “**3.**” and substitute “**2.**”.
