House Bill 411 (Delegate Korman)
Health and Government Operations

State Designations – State Mineral – Chromite (State Mineral Act)

This bill designates Chromite as the State mineral.

Fiscal Summary

State Effect: Designating a State mineral does not materially affect State finances.

Local Effect: None.

Small Business Effect: None.

Analysis

Current Law: Since the adoption of the Maryland State Flag in 1904 and the adoption of the Black-eyed Susan as the State flower in 1918, the State has adopted many official symbols, as shown in **Exhibit 1**. The Governor is also authorized to designate a citizen as the State’s Poet Laureate.
