---

**Baltimore City - Ordinance Enforcement - Fines and Penalties**

---

This bill repeals the maximum civil and criminal fines and penalties Baltimore City may impose for the violation of any ordinance, rule, or regulation established by the city, as specified.

---

**Fiscal Summary**

**State Effect:** The bill does not materially affect State operations or finances.

**Local Effect:** Baltimore City revenues may increase, beginning in FY 2027, to the extent that higher fines or penalties are imposed for civil or criminal offenses. Baltimore City expenditures are not affected.

**Small Business Effect:** None.

**Analysis**

**Current Law:** Baltimore City is authorized to provide civil and criminal fines and penalties for the violation of any ordinance, rule, or regulation established by the city, as specified. The maximum fine or penalty for these violations is \$1,000.

**Local Fiscal Effect:** Baltimore City revenues increase, beginning in fiscal 2027, to the extent higher fines are imposed and collected under the bill. In fiscal 2024, the Baltimore City Environmental Control Board (ECB) issued 7,778 environmental citations totaling approximately \$7.8 million, as shown in **Exhibit 1**. Baltimore City collected \$5.9 million in fine revenues from these environmental citations, a 75.8% collection rate. In addition, Baltimore City collected \$1,630 from other civil citations in fiscal 2024.

Baltimore City advises that significantly higher fines may initially serve to reduce collection rates. However, any unpaid ECB fines can result in property liens, and the potential for a property to be sent to tax sale may serve as incentive for payment.
