Access to Health Insurance for Child Care Professionals - Outreach

This bill requires the Maryland Health Benefit Exchange (MHBE) to promote access to health insurance for child care professionals by (1) partnering with the Maryland State Department of Education (MSDE), prekindergarten provider hubs, child care associations, and relevant nonprofit organizations; (2) helping child care professionals obtain health insurance through MHBE or Medicaid; (3) assisting child care professionals who lose Medicaid coverage with finding alternative health insurance options; (4) helping ensure health plan options meet the budgets and health insurance needs of child care professionals and child care employers; (5) providing informational resources; and (6) assessing current levels of health care access across the child care community by conducting a survey developed in consultation with MSDE and relevant nonprofit organizations and with a particular emphasis on providers who accept child care scholarship (CCS) vouchers.

Fiscal Summary

State Effect: MHBE special fund expenditures increase by \$250,000 in FY 2026 only to promote access to health insurance for child care professionals and conduct the survey, as discussed below. MSDE can partner with MHBE using existing resources. Any ongoing expenses for MHBE can be absorbed within existing resources. Revenues are not affected.

Analysis

Current Law:

Maryland Health Benefit Exchange

MHBE was created during the 2011 session to provide a marketplace for individuals and small businesses to purchase affordable health coverage. Through the Maryland Health Connection, Maryland residents can shop for health insurance plans, compare rates, and determine their eligibility for federal advanced premium tax credits and Medicaid.

Child Care

“Prekindergarten provider hub” means a coordinated partnership between eligible prekindergarten providers and other entities established by MSDE.

The State oversees a variety of early education services that are provided to Maryland children and their families in cooperation with local governments, local school systems, and private child care providers.

The CCS Program (formerly known as the Child Care Subsidy Program) provides financial assistance with child care costs to low-income families that meet applicable State or federal requirements. The program is funded through a combination of State funds and the federal Child Care and Development Block Grant. All participating parents or guardians must meet a variety of technical requirements and must be working or enrolled in school, a training program, or a work-related activity.

State Expenditures: Under the bill, MHBE must promote access to health insurance for child care professionals, help child care professionals obtain health insurance, assist child care professionals who lose Medicaid coverage find alternative coverage, help ensure health plan options meet the budgets and health insurance needs of child care professionals and employers, provide informational resources, and assess current levels of health care access across the child care community by conducting a specified survey. To complete these requirements, MHBE advises that it will prepare and conduct a targeted outreach campaign to help child care workers enroll in health insurance and conduct a survey of the landscape and availability of health insurance among child care providers at an estimated total cost of \$250,000 in fiscal 2026 only. Work will be completed by existing MHBE staff in coordination with statewide [Connector Entity](#) partners. This estimate includes the cost of conducting the outreach campaign and survey, as well as associated printing, mailing, and communications costs.
