AMENDMENTS TO HOUSE BILL 864
(Third Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 6, strike “qualified” and substitute “qualifying new”; in line 8, strike “repealing” and substitute “altering”; and strike beginning with “authorizing” in line 11 down through “circumstances;” in line 12.

AMENDMENT NO. 2

On page 6, in line 13, strike “AN” and substitute “A QUALIFYING”; in the same line, strike “A”; in line 16, strike the colon; in line 17, strike “**(1)**”; and strike beginning with the semicolon in line 18 down through “**30**” in line 20.

On page 7, in line 12, strike “**QUALIFIED**” and substitute “QUALIFYING”; in line 16, strike “**OR**”; after line 16, insert:

“(2) IS CURRENTLY COMPLETING, OR HAS COMPLETED WITHIN 3 YEARS BEFORE THE START DATE OF THE COVERED PROJECT, THE EQUIVALENT OF AN APPRENTICESHIP IN LENGTH AND CONTENT OF WORK EXPERIENCE AND ALL REQUIREMENTS IN THE APPRENTICESHIP STANDARDS FOR A CRAFT; OR”;

in line 17, strike “**(2)**” and substitute “**(3)**”; in the same line, strike “**PARTICIPATING**” and substitute “ENROLLED”; in line 19, strike “APPRENTICESHIP-CONNECTED” and substitute “APPRENTICESHIP”; in line 20, after the first “PROGRAM” insert “, APPRENTICESHIP PROGRAM,”; and strike beginning with the colon in line 20 down through “**(2)**” in line 24.

On page 8, in line 28, strike “APPRENTICESHIP-CONNECTED” and substitute “APPRENTICESHIP”.

On page 9 in lines 18, 19, 24, 27, and 31, and on page 10 in lines 6, 11, 12, 16, 19, 23, and 30, in each instance, strike the bracket.

On page 9 in line 19, and on page 10 in line 12, in each instance, before “IS” insert “AND”.

On page 9 in line 22, and on page 10 in line 14, in each instance, strike “OR”.

On page 9 in lines 26 and 27, and on page 10 in lines 18 and 19, in each instance, strike “registered apprenticeship program or to an organization that has registered apprenticeship programs” and substitute “QUALIFIED APPRENTICESHIP PROGRAM”.

On page 9 in line 31, and on page 10 in lines 4, 23, and 28, in each instance, strike “registered” and substitute “QUALIFIED”.

On page 9 in line 20, on page 10 in line 13, and on page 13 in line 25, in each instance, strike “QUALIFIED” and substitute “QUALIFYING NEW”.

On page 12, in line 1, after “FUND” insert “OR A QUALIFIED APPRENTICESHIP PROGRAM”; in lines 3 and 18, in each instance, strike “QUALIFIED” and substitute “QUALIFYING NEW”; strike beginning with the comma in line 27 down through “apprenticeship” in line 28 and substitute “OR A QUALIFIED APPRENTICESHIP”; in line 29, after “preapprenticeship” insert “, APPRENTICESHIP,”; and in line 32, after “received” insert “FOR CONTRIBUTIONS TO THE FUND”.
