AMENDMENTS TO SENATE BILL 176  
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 5, strike “restitution or child support” and substitute “certain restitution, child support, and State debt”; and strike beginning with “authorizing” in line 7 down through “operator;” in line 9.

On page 2, in line 4, after “3–304(a)” insert “and 3–307(c)(2)”.

AMENDMENT NO. 2

On page 3, in line 21, strike “send a notice to” and substitute “NOTIFY”; and in line 29, strike “has 15 days to” and substitute “MAY”.

On page 4, in line 1, strike “on interception of the prize” and substitute “IF AN APPEAL IS NOT FILED WITHIN 15 DAYS AFTER THE DATE OF THE NOTICE”; strike beginning with the colon in line 4 down through “(i)” in line 5; in line 5, strike “and transfer”; strike beginning with “to” in line 6 down through “obligor” in line 7; in line 19, after “transfer” insert “IN ACCORDANCE WITH TITLE 10, SUBTITLE 2 OF THE STATE GOVERNMENT ARTICLE”; strike beginning with the third “the” in line 20 down through “prize” in line 21 and substitute “THE AGENCY OR VIDEO LOTTERY OPERATOR SHALL TRANSFER THE AMOUNT OF THE PRIZE WITHHELD IN ACCORDANCE WITH SUBSECTION (E)(2) OF THIS SECTION”; strike beginning with “by” in line 22 down through “Unit” in line 23 and substitute “IN ACCORDANCE WITH TITLE 10, SUBTITLE 2 OF THE STATE GOVERNMENT ARTICLE”; and in lines 25 and 26 and 27, in each instance, strike “retained by the Central Collection Unit” and substitute “PAID IN ACCORDANCE WITH SUBSECTION (E)(2) OF THIS SECTION”.

On page 5, in line 18, strike “provide a notice to” and substitute “**NOTIFY**”; in line 27, strike “has 15 days to” and substitute “**MAY**”; and in line 29, strike “on interception of the prize” and substitute “**IF AN APPEAL IS NOT FILED WITHIN 15 DAYS AFTER THE DATE OF THE NOTICE**”.

On page 6, strike beginning with the colon in line 1 down through “(i)” in line 2; strike beginning with the semicolon in line 3 down through “obligor” in line 4; in line 22, strike “retained by the Administration” and substitute “**PAID IN ACCORDANCE WITH SUBSECTION (F)(2) OF THIS SECTION**”; and strike beginning with “retained” in line 23 down through “specified” in line 24 and substitute “**PAID IN ACCORDANCE WITH SUBSECTION (F)(2) OF THIS SECTION**”.

On page 7, after line 21, insert:

“3-307.

(c) (2) The State Lottery and Gaming Control Agency shall honor lottery prize interception requests in the following order:

(i) an interception request under § 10-113.1 of the Family Law Article;

(ii) an interception request under § 11-618 of the Criminal Procedure Article; [and]

(iii) an interception request under this section; AND

(IV) AN INTERCEPTION REQUEST UNDER § 3-308 OF THIS SUBTITLE.”.

On page 8, in line 3, after the first “OPERATOR” insert “REQUIRING THE ISSUANCE OF INTERNAL REVENUE SERVICE FORM W-2G OR A SUBSTANTIALLY EQUIVALENT FORM BY THE VIDEO LOTTERY OPERATOR”; in line 25, strike “AND”; and in line 26, after “(III)” insert “AN INTERCEPTION REQUEST UNDER § 3-307 OF THIS SUBTITLE; AND

(IV)”.

On page 9, in line 7, after “HEARING” insert “HELD IN ACCORDANCE WITH TITLE 10, SUBTITLE 2 OF THE STATE GOVERNMENT ARTICLE,”.
