AMENDMENT NO. 1

On page 1, in the sponsor line, strike “**Senator McCray**” and substitute “**Senators McCray, Augustine, Guzzone, Hettleman, King, Lewis Young, Rosapepe, and Zucker**”; in line 4, strike “all” and substitute “certain”; in line 5, after “impasse” insert “in negotiations between certain parties”; and in line 8, after “bill” insert “submitted by the Governor”.

AMENDMENT NO. 2

On page 4, in line 4, after “TO” insert “:

1. A BARGAINING UNIT IN A STATE INSTITUTION OF HIGHER EDUCATION, INCLUDING THE UNIVERSITY SYSTEM OF MARYLAND; OR

On page 5, in line 5, strike the bracket; in the same line, after “(1)” insert “**THIS SUBSECTION APPLIES ONLY WITH RESPECT TO A STATE INSTITUTION OF HIGHER EDUCATION, INCLUDING THE UNIVERSITY SYSTEM OF MARYLAND.**

in line 7, strike “(2)” and substitute “**(3)**”; in the same line, strike “(i)”; strike beginning with “(ii)” in line 10 down through “year.” in line 15; strike beginning with “(3)” in line 16 down through “(ii)” in line 19 and substitute “**(4)**”; in line 22, strike “(iii)” and substitute “**(5)**”; in line 23, strike “(iv)” and substitute “**(6)**”; in lines 25 and 26, strike “1.” and “2.”, respectively, and substitute “**(I)**” and “**(II)**”, respectively; in line 28, strike

“(v)” and substitute “**(7)**”; in lines 29, 31, and 33, strike “1.”, “2.”, and “3.”, respectively, and substitute “**(I)**”, “**(II)**”, and “**(III)**”, respectively.

On page 6, in line 1, strike “4.” and substitute “**(IV)**”; in line 4, strike “(vi)” and substitute “**(8)**”; in line 6, strike the bracket; and in line 7, before “**(1)**” insert “**(D)**”.

On page 7, in line 16, strike “(d)” and substitute “**(E)**”; in line 28, after “(2)” insert “**(I) THIS PARAGRAPH DOES NOT APPLY TO MATTERS INVOLVING A STATE INSTITUTION OF HIGHER EDUCATION, INCLUDING THE UNIVERSITY SYSTEM OF MARYLAND.**”

(II);

and in line 30, before “approval” insert “**LEGISLATIVE**”.

On page 8, in line 2, after “approval” insert “**OR THE APPROPRIATION OF FUNDS**”; in the same line, strike “legislation” and substitute “**MATTERS**”; in line 3, after “Assembly” insert “**FOR LEGISLATIVE APPROVAL OR THE APPROPRIATION OF FUNDS**”; in line 4, strike “(e)” and substitute “**(F)**”; in line 9, strike “(f)” and substitute “**(G)**”; and in line 21, after the first “**BENEFITS**” insert “**OTHER THAN PENSION BENEFITS**”.

On page 9, after line 1, insert:

“**(A) THIS SECTION DOES NOT APPLY WITH RESPECT TO A STATE INSTITUTION OF HIGHER EDUCATION, INCLUDING THE UNIVERSITY SYSTEM OF MARYLAND.**”;

in line 2, strike “**(A)**” and substitute “**(B)**”; and in line 20, strike “**(B)**” and substitute “**(C)**”.

On page 11, in line 27, strike “OR STATE INSTITUTIONS OF HIGHER EDUCATION”.

On page 12, after line 16, insert:

“(8) A WRITTEN AWARD REQUIRED UNDER THIS SUBSECTION SHALL INCLUDE A STATEMENT, PREPARED IN CONSULTATION WITH BOTH PARTIES, DETAILING THE MULTI-YEAR FISCAL IMPACT TO THE GENERAL FUND OF THE STATE FROM PARAGRAPH (7)(IV) AND (V) OF THIS SUBSECTION.”;

in line 17, strike “(C)” and substitute “(D)”; in line 19, after “REQUIRING” insert “A CHANGE IN LAW OR”; in line 20, before “APPROVAL” insert “ENACTMENT OF LEGISLATION MAKING THE CHANGE IN LAW OR”; in line 25, strike “(D)” and substitute “(E)”; in the same line, strike “, A STATE INSTITUTION OF HIGHER EDUCATION,”; and in line 29, strike “(E)” and substitute “(F)”.

On page 13, in line 5, strike “(F)” and substitute “(G)”; and in line 8, strike “(G)” and substitute “(H)”.

On page 14, in line 9, after “BUDGET” insert “SUBMITTED BY THE GOVERNOR”; and in the same line, after “THE” insert “PROPOSED”; in line 11, after “STATE” insert “AND ANY INSTITUTION OF HIGHER EDUCATION INCLUDING THE UNIVERSITY SYSTEM OF MARYLAND”; in line 13, strike “STATE INSTITUTIONS OF HIGHER EDUCATION,”; and in line 16, strike “, INCLUDING HIGHER EDUCATION”.

On page 18, in line 1, after “budget” insert “submitted by the Governor”.
