CHAPTER _____

1 AN ACT concerning

2 **State Board of Morticians and Funeral Directors – Board Operations and**
3 **Regulation of Crematories and Reduction Facilities**

4 FOR the purpose of transferring the authority to regulate certain crematories and
5 reduction facilities from the Office of Cemetery Oversight to the State Board of
6 Morticians and Funeral Directors; ~~renaming the Board to be the State Board of~~
7 ~~Morticians, Funeral Directors, and Crematories~~; altering the circumstances under
8 which the Governor may remove an appointed member of the Board; altering the
9 quorum of the Board; specifying that the Board may take action with a simple
10 majority vote of the quorum; and generally relating to the State Board of Morticians
11 and Funeral Directors.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 14 That the Laws of Maryland read as follows:

15 **Article – Business Regulation**

16 5–101.

17 (a) In this title the following words have the meanings indicated.

18 (b) [“Alkaline hydrolysis” means the process of reducing human remains using
 19 water, alkaline chemicals, and heat inside a watertight vessel to accelerate decomposition.

20 (c) [“Authorizing agent” has the meaning stated in § 5–508 of the Health – General
 21 Article.

22 [(d)] (C) (1) “Burial goods” means goods that are used in connection with
 23 burial.

24 (2) “Burial goods” includes:

25 (i) a casket;

26 (ii) a grave liner;

27 (iii) a memorial;

28 (iv) a monument;

29 (v) a scroll;

30 (vi) an urn;

1 (vii) a vase; and

2 (viii) a vault.

3 **[(e)] (D)** “Burial goods business” means a business that provides burial goods.

4 **[(f)] (E)** (1) “Cemetery” means land used or to be used for interment.

5 (2) “Cemetery” includes a structure used or to be used for interment.

6 **[(g)] (F)** “Cremation” means the disposition of a dead human body by means of
7 incineration.

8 **[(h)] (G)** “Crematory” means a building, portion of a building, or structure that
9 houses the necessary appliances and facilities for cremation or alkaline hydrolysis.

10 **[(i)] (H)** “Director” means the Director of the Office of Cemetery Oversight.

11 **[(j)] (I)** “Engage in the operation of a cemetery” means owning, controlling, or
12 managing a cemetery, including performing activities necessary for:

13 (1) the establishment, improvement, care, preservation, or embellishment
14 of a cemetery;

15 (2) interment; and

16 (3) the providing of burial space or burial goods.

17 **[(k)] (1)** “Engage in the operation of a crematory” means controlling or
18 managing a crematory.

19 (2) “Engage in the operation of a crematory” does not include:

20 (i) the practice of funeral direction or the practice of mortuary
21 science; or

22 (ii) 1. assistance in making decisions and filling out forms that
23 are not directly related to cremation;

24 2. obtaining vital statistics, signatures, and other
25 information necessary to complete a death certificate;

26 3. transportation of a body to the place of disposition; or

27 4. any other services regarding the disposition of a body that
28 are not directly related to cremation.

1 (l) (1) “Engage in the operation of a reduction facility” means controlling or
2 managing a reduction facility.

3 (2) “Engage in the operation of a reduction facility” does not include:

4 (i) the practice of funeral direction or the practice of mortuary
5 science; or

6 (ii) 1. assistance in making decisions and filling out forms that
7 are not directly related to natural organic reduction;

8 2. obtaining vital statistics, signatures, and other
9 information necessary to complete a death certificate;

10 3. transportation of a body to the place of disposition; or

11 4. any other services regarding the disposition of a body that
12 are not directly related to natural organic reduction.]

13 [(m)] (J) “Funeral establishment” means a building, structure, or premises from
14 which the business of funeral directing or embalming is conducted.

15 [(n)] (K) (1) “Human remains” means:

16 (i) the body of a deceased person; or

17 (ii) a part of a body or limb that has been removed from a living
18 person.

19 (2) “Human remains” includes the body or part of a body or limb in any
20 state of decomposition.

21 (3) “Human remains” does not include soil remains produced after the
22 completion of natural organic reduction.

23 [(o) “Hydrolyzed remains” means the bone fragments produced by the completion
24 of alkaline hydrolysis.]

25 [(p)] (L) “Interment” means all final disposition of human remains or pet
26 remains, including:

27 (1) earth burial;

28 (2) mausoleum entombment; and

1 (3) niche or columbarium interment.

2 [(q)] (M) “Natural organic reduction” means the contained accelerated
3 conversion of human remains into soil.

4 [(r)] (N) “Office” means the Office of Cemetery Oversight.

5 [(s)] (O) “Permit” means a permit issued by the Director to allow a partnership,
6 limited liability company, or corporation to operate a business through which a registrant
7 may:

8 (1) engage in the operation of a cemetery [or crematory]; or

9 (2) provide burial goods.

10 [(t)] (P) (1) “Pet remains” means the body of a deceased animal that was kept
11 as a pet.

12 (2) “Pet remains” includes the body of a pet or a part of a pet’s body in any
13 state of decomposition or the body of a pet after having been cremated.

14 [(u)] (Q) (1) “Preneed goods” means burial goods that are sold before the
15 buyer’s death.

16 (2) “Preneed goods” does not include burial space.

17 [(v)] (R) “Provide burial goods” means a retail transaction:

18 (1) to erect, service, or inscribe burial memorials; or

19 (2) to sell burial goods.

20 [(w)] “Reduction facility” means a building, portion of a building, or structure that
21 houses the necessary appliances, containers, and facilities for performing natural organic
22 reduction.]

23 [(x)] (S) “Registered cemeterian” means an individual registered to operate a
24 cemetery as a sole proprietor or on behalf of a sole proprietor or of a permit holder.

25 [(y)] “Registered crematory operator” means an individual registered to operate a
26 crematory as a sole proprietor or on behalf of a sole proprietor or permit holder.

27 (z) “Registered reduction operator” means an individual registered to operate a
28 reduction facility as a sole proprietor or on behalf of a sole proprietor or a permit holder.]

1 [(aa)] (T) “Registered seller” means an individual registered to provide burial
2 goods as a sole proprietor or on behalf of a sole proprietor or of a permit holder.

3 [(bb)] (U) “Registration” means a registration issued by the Director authorizing
4 an individual to operate a cemetery[, to operate a crematory, to operate a reduction
5 facility,] or to provide burial goods.

6 [(cc)] (V) “Responsible party” means a sole proprietor or the individual
7 designated by a partnership, limited liability company, or corporation to be responsible for
8 the operations of a cemetery[, crematory, reduction facility,] or burial goods business.

9 [(dd)] “Soil remains” means the soil produced at final disposition of a dead human
10 body at a reduction facility by completion of natural organic reduction.]

11 5–102.

12 (b) This title does not apply to:

13 (1) the operation of a funeral establishment, including the sale of burial
14 goods in the ordinary course of the funeral establishment’s business;

15 [(2) the operation or ownership of a crematory in which a person who is
16 licensed and regulated under Title 7 of the Health Occupations Article owns a greater
17 percentage of the crematory than a registered cemeterian, registered seller, or holder of a
18 permit for the operation of a cemetery or burial goods business;]

19 [(3)] (2) the operation or ownership of a crematory [or], incinerator [at a
20 licensed medical facility or educational institution], **OR REDUCTION FACILITY**;

21 [(4)] (3) a licensed funeral director acting within the scope of the funeral
22 director’s license; or

23 [(5)] (4) a mortician acting within the scope of the mortician’s license.

24 5–201.

25 (a) There is an Office of Cemetery Oversight in the Department.

26 (b) The Office exercises its rights, powers, and duties subject to the authority of
27 the Secretary.

28 (c) (1) The Secretary shall appoint an Advisory Council on Cemetery
29 Operations.

30 (2) The Advisory Council consists of [12] 11 members.

1 (3) Of the [12] 11 members of the Advisory Council:

2 (i) three shall be registered cemeterians representing the for-profit
3 cemetery industry;

4 (ii) one shall be a registered cemeterian representing a nonprofit
5 cemetery;

6 (iii) one shall be a registered seller from a monument company;

7 (iv) one shall be a representative from a religious cemetery; AND

8 (v) [one shall be a representative from a crematory; and

9 (vi)] five shall be consumer members.

10 (4) The Advisory Council shall be convened at least four times a year to
11 give advice to the Secretary and the Director.

12 (5) In addition to the required meetings, the Advisory Council may meet as
13 necessary.

14 (d) The term of a member is 3 years.

15 5-204.

16 (a) [(1)] With the advice of the Advisory Council and after consultation with
17 representatives of the cemetery industry, the Director shall adopt:

18 [(i)] (1) rules and regulations to carry out this title; and

19 [(ii)] (2) a code of ethics for engaging in the operation of a
20 cemetery[, crematory, or reduction facility] or providing burial goods.

21 [(2)] In conjunction with the State Board of Morticians and Funeral
22 Directors, the Director shall:

23 (i) establish a process for regulating crematories and reduction
24 facilities that provides for:

25 1. registration of crematory operators and reduction facility
26 operators or issuance of permits for operating crematories and reduction facilities, and
27 renewal;

1 2. applications, including certification of ownership and
2 identification of individuals who will perform alkaline hydrolysis, cremation, or natural
3 organic reduction;

4 3. registration and permit fees;

5 4. inspections and oversight;

6 5. grounds for discipline and penalties; and

7 6. complaints and hearings; and

8 (ii) adopt regulations that are identical to regulations adopted by the
9 State Board of Morticians and Funeral Directors to:

10 1. implement item (i) of this paragraph; and

11 2. ensure public health and safety.

12 (3) The Director shall adopt regulations that:

13 (i) require a registered reduction operator to notify the authorizing
14 agent in writing and before initiating natural organic reduction that a person who uses or
15 disposes of soil remains is in violation of § 5–514 of the Health – General Article;

16 (ii) require a reduction facility to monitor and record written
17 verification that the temperature during each instance of a natural organic reduction
18 process attains a specified minimum internal equipment temperature for a specified
19 minimum period of time;

20 (iii) establish appropriate standards for training and experience for
21 the registration of reduction operators;

22 (iv) prohibit the use of natural organic reduction in any instance in
23 which the human remains are known, or reasonably suspected, to be embalmed or to have
24 an infection, disease, or biological condition that renders the process of natural organic
25 reduction or the resulting soil remains unreasonably unsafe, including:

26 1. Creutzfeldt–Jakob disease or other prion disease;

27 2. Ebola virus infection;

28 3. Mycobacterium tuberculosis infection;

29 4. the presence of diagnostic or therapeutic radioisotopes; or

1 (b) (1) [(i)] By regulation, the Director shall establish reasonable fees and a
2 fee schedule for the issuance and renewal of registrations and permits.

3 [(ii) The Director may not assess a crematory a per-occurrence
4 cremation fee.]

5 (2) In establishing the fees, the Director shall consider:

6 (I) the size of the business[.];

7 (II) whether the business is for-profit or designated as tax exempt
8 under § 501(c) of the Internal Revenue Code[.];

9 (III) the volume of business conducted[.]; and

10 (IV) the type of services provided, including the percentage of preneed
11 contracts written.

12 5-301.

13 An individual shall register with the Office before:

14 (1) engaging in the operation of a cemetery[, crematory, or reduction
15 facility] in this State; or

16 (2) providing burial goods in this State.

17 5-302.

18 (a) In order to register, an applicant shall meet the requirements of this section.

19 (b) The applicant must be at least 18 years old.

20 (c) The applicant must be of good character and reputation.

21 (d) The applicant must be affiliated with a cemetery[, crematory, reduction
22 facility,] or burial goods business operated by a registrant or permit holder.

23 (e) The cemetery[, crematory, reduction facility,] or burial goods business with
24 which the applicant is affiliated must be financially stable in accordance with § 5-304 of
25 this subtitle.

26 5-303.

27 (a) An applicant shall register by:

1 (1) submitting to the Director an application on the form that the Director
2 provides; and

3 (2) paying a nonrefundable application fee set by the Director.

4 (b) The application shall state:

5 (1) the name, date of birth, and residential address of the applicant;

6 (2) the name and fixed address of the affiliated cemetery[, crematory,] or
7 burial goods business;

8 (3) whether the cemetery[, crematory, reduction facility,] or burial goods
9 business with which the applicant is affiliated is owned or controlled by a sole proprietor,
10 partnership, limited liability company, or corporation;

11 (4) if the applicant is designated as the responsible party, the name and
12 residential address of each employee who sells burial space, goods, or services to the public
13 for the business while engaging in the operation of a cemetery[, crematory, reduction
14 facility,] or burial goods business; and

15 (5) any other reasonable information that the Director determines is
16 necessary to carry out this title.

17 5-306.

18 (a) While a registration is in effect, it authorizes the registrant to engage in the
19 operation of a cemetery[, crematory, reduction facility,] or burial goods business.

20 (b) This title does not limit the right of a person to practice funeral direction or
21 mortuary science[, or operate a crematory,] if the person is licensed or otherwise authorized
22 under Title 7 of the Health Occupations Article.

23 5-308.

24 Within 1 week after the effective date of the change, the applicant designated as the
25 responsible party or the registered responsible party shall submit to the Director an
26 application form that shows a change in the:

27 (1) cemetery[, crematory, reduction facility,] or burial goods business with
28 which a registrant is affiliated;

29 (2) individual designated as the responsible party;

1 (3) employees of the business who engage in the sale of burial space, goods,
2 or services [or cremation] to the public;

3 (4) officers, directors, members, or agents of the permit holder; or

4 (5) name or address of the registrant or permit holder.

5 5–310.

6 (a) Subject to the hearing provisions of § 5–312 of this subtitle, the Director may
7 deny a registration or permit to an applicant, reprimand a person subject to the registration
8 or permit provisions of this title, or suspend or revoke a registration or permit if an
9 applicant, registrant, or permit holder, or an agent, employee, officer, director, or partner
10 of the applicant, registrant, or permit holder:

11 (1) fraudulently or deceptively obtains or attempts to obtain a registration
12 or permit;

13 (2) fraudulently or deceptively uses a registration or permit;

14 (3) under the laws of the United States or of any state, is convicted of a:

15 (i) felony; or

16 (ii) misdemeanor that is directly related to the fitness and
17 qualifications of the applicant, registrant, or permit holder to own or operate a cemetery[,
18 crematory, or reduction facility] or provide burial goods;

19 (4) fails to provide or misrepresents any information required to be
20 provided under this title;

21 (5) violates this title;

22 (6) violates the code of ethics adopted by the Director;

23 (7) violates a regulation adopted under this title;

24 (8) fails to provide reasonable and adequate supervision of the operation of
25 the cemetery[, crematory, or reduction facility] or the provision of burial goods by agents,
26 employees, officers, directors, or partners affiliated with a cemetery[, crematory, reduction
27 facility,] or burial goods business;

28 (9) refuses to allow an inspection required by this title;

29 (10) fails to comply with an order of the Director;

1 (11) fails to comply with any terms of settlement under a binding arbitration
2 agreement;

3 (12) is found guilty by a court in this State of violating an unfair, **ABUSIVE**,
4 or deceptive trade practices provision under Title 13 of the Commercial Law Article; or

5 (13) fails to comply with § 5–513 of the Health – General Article.

6 (b) (1) If a person is charged with a violation of this title that could result in
7 suspension or revocation of a registration or permit, the Director may seek an immediate
8 restraining order in a circuit court in this State to prohibit the person from engaging in the
9 operation of any cemetery[, crematory, reduction facility,] or burial goods business.

10 (2) The restraining order is in effect until:

11 (i) the court lifts the order; or

12 (ii) the charges are adjudicated or dismissed.

13 5–311.

14 (c) (1) The Director or the Director’s designee shall review each complaint and
15 shall attempt to negotiate a settlement of the complaint between the complainant and the
16 registrant, permit holder, or any other person subject to the registration or permit
17 provisions of this title.

18 (2) Notwithstanding § 5–102 of this title, the Director or the Director’s
19 designee may receive and attempt to negotiate a settlement to resolve complaints
20 concerning persons required to file statements under § 5–405 of this title and in connection
21 with the operation of a cemetery [or crematory] or the sale of preneed goods.

22 (3) The Director may not take any actions described in subsection (d)(1)
23 and (2) of this section for complaints involving persons exempt under § 5–102 of this title.

24 5–401.

25 (a) Subject to the provisions of this section, a registered cemeterian[, registered
26 crematory operator, registered reduction operator,] or registered seller may engage in the
27 operation of a cemetery[, crematory, reduction facility,] or burial goods business as a sole
28 proprietor or through:

29 (1) a corporation as an officer, director, employee, or agent of the
30 corporation;

31 (2) a limited liability company as a member, employee, or agent of the
32 limited liability company; or

1 (3) a partnership as a partner, employee, or agent of the partnership.

2 (b) Subject to the provisions of this title, a corporation, limited liability company,
3 or partnership may engage in the operation of a cemetery[, crematory, reduction facility,]
4 or burial goods business through a registered cemeterian[, registered crematory operator,
5 registered reduction operator,] or registered seller.

6 (c) (1) A registered cemeterian who engages in the operation of a cemetery
7 through a corporation, limited liability company, or partnership under this title is subject
8 to all of the provisions of this title that relate to engaging in the operation of a cemetery.

9 (2) [A registered crematory operator who engages in the operation of a
10 crematory through a corporation, limited liability company, or partnership under this title
11 is subject to all of the provisions of this title that relate to engaging in the operation of a
12 crematory.

13 (3) A registered reduction operator who engages in the operation of a
14 reduction facility through a corporation, limited liability company, or partnership under
15 this title is subject to all the provisions of this title that relate to engaging in the operation
16 of a reduction facility.

17 (4)] A registered seller who engages in the operation of a burial goods
18 business through a corporation, limited liability company, or partnership under this title is
19 subject to all of the provisions of this title that relate to providing burial goods services.

20 (d) (1) A corporation, limited liability company, or partnership that engages in
21 the operation of a cemetery[, crematory, reduction facility,] or burial goods business under
22 this title is not, by its compliance with this title, relieved of any responsibility that the
23 corporation, limited liability company, or partnership may have for an act or an omission
24 by its officer, director, member, partner, employee, or agent.

25 (2) An individual who engages in the operation of a cemetery[, crematory,
26 reduction facility,] or burial goods business through a corporation, limited liability
27 company, or partnership is not, by reason of the individual's employment or other
28 relationship with the corporation, limited liability company, or partnership, relieved of any
29 individual responsibility that the individual may have regarding that practice.

30 5-402.

31 A corporation, limited liability company, or partnership shall obtain a permit issued
32 by the Director, before the corporation, limited liability company, or partnership may
33 engage in the operation of a cemetery[, crematory, reduction facility,] or burial goods
34 business in the State.

35 5-403.

1 To qualify for a permit, a corporation, limited liability company, or partnership shall:

2 (1) designate a separate registered cemeterian[, registered crematory
3 operator, registered reduction operator,] or registered seller as the responsible party for
4 the operations of each affiliated cemetery[, crematory, reduction facility,] or burial goods
5 business;

6 (2) provide the name and business address of each affiliated cemetery[,
7 crematory, reduction facility,] or burial goods business;

8 (3) provide a list of the officers, directors, members, partners, agents, and
9 employees of the entity applying for the permit; and

10 (4) comply with §§ 5–303(b)(4) and 5–304 of this title.

11 5–701.

12 (a) In this subtitle the following words have the meanings indicated.

13 (e) (1) “Preneed services” means services that are sold:

14 (i) before the buyer’s death; and

15 (ii) in connection with burial [or cremation].

16 (2) “Preneed services” includes opening and closing a grave.

17 (f) “Seller” means a registered cemeterian, [registered crematory operator,]
18 registered seller, or any other person who sells preneed goods or preneed services.

20 ~~(a) This subtitle does not apply to:~~

21 ~~(1) the sale of burial space;~~

22 ~~(2) a preneed contract made by an individual in connection with:~~

4 (f) A trustee may not use any preneed trust funds required to be held in trust in
5 accordance with this subtitle to:

6 (1) purchase an interest in any contract or agreement to which the
7 registrant, the permit holder, or any other person subject to the trust requirements of this
8 subtitle, or any entity owned or under the control of a registrant, a permit holder, or any
9 other person subject to the trust requirements of this subtitle, or a spouse, child, parent, or
10 sibling of a registrant or any other person subject to the trust requirements of this subtitle
11 is a party; or

12 (2) make any loan or direct or indirect investment of any kind:

13 (i) to any registrant, permit holder, or any other person subject to
14 the trust requirements of this subtitle or to any spouse, child, parent, or sibling of a
