## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Child Abuse and Neglect – Disclosure of Reports and Records**

3 FOR the purpose of expanding the circumstances under which a report or record concerning  
4 child abuse or neglect may be disclosed by the Department of Human Services to  
5 certain individuals; and generally relating to disclosure of reports and records of  
6 child abuse and neglect.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
18 That the Laws of Maryland read as follows:

19 **Article – Human Services**

20 1–202.

1 (a) Except as otherwise provided in Title 5, Subtitles 7 and 12 of the Family Law  
2 Article, § 1–203 of this subtitle, and this section, a person may not disclose a report or  
3 record concerning child abuse or neglect.

4 (c) A report or record concerning child abuse or neglect:

5 (1) may be disclosed on request to:

6 (i) personnel of the Social Services Administration or a local  
7 department of social services, law enforcement personnel, and members of  
8 multidisciplinary case consultation teams, including an addiction specialist as defined in  
9 Title 5, Subtitle 12 of the Family Law Article or § 5–314 of this article, who are investigating  
10 a report of known or suspected child abuse or neglect or providing services to or assessing  
11 a child or family that is the subject of the report;

12 (ii) local or State officials responsible for the administration of child  
13 protective services, juvenile services, or child care, foster care, or adoption licensing,  
14 approval, or regulations, as necessary to carry out their official functions;

15 (iii) the State Council on Child Abuse and Neglect or its designee, the  
16 State Citizens Review Board for Children or its designee, or a child fatality review team,  
17 as necessary to carry out their official functions;

18 (iv) a person who is the alleged abuser or neglector, if that person is  
19 responsible for the child's welfare and provisions are made for the protection of the identity  
20 of the reporter or any other person whose life or safety is likely to be endangered by  
21 disclosing the information;

22 (v) a licensed practitioner who, or an agency, institution, or program  
23 that, is providing treatment or care to a child who is the subject of a report of child abuse  
24 or neglect for a purpose relevant to the treatment or care;

25 (vi) a parent or other person who has permanent or temporary care  
26 and custody of the child, if provisions are made for the protection of the identity of the  
27 reporter or any other person whose life or safety is likely to be endangered by disclosing the  
28 information;

29 (vii) 1. the appropriate public school superintendent or the  
30 principal or equivalent employee of a nonpublic school that holds a certificate of approval  
31 from the State or is registered with the State Department of Education to carry out  
32 appropriate personnel or administrative actions following a report of suspected child abuse  
33 involving a student committed by:

34 A. a public school employee in that school system;

35 B. an employee of that nonpublic school;

1 C. an independent contractor who supervises or works  
2 directly with students in that school system or that nonpublic school; or

3 D. an employee of an independent contractor, including a bus  
4 driver or bus assistant, who supervises or works directly with students in that school  
5 system or that nonpublic school; and

6 2. if the report concerns suspected child abuse involving a  
7 student committed by an employee, independent contractor, or employee of an independent  
8 contractor described in item 1 of this item and employed by a nonpublic school under the  
9 jurisdiction of the superintendent of schools for the Archdiocese of Baltimore, the  
10 Archdiocese of Washington, or the Catholic Diocese of Wilmington, the appropriate  
11 superintendent of schools;

12 (viii) the director of a licensed child care facility or licensed child  
13 placement agency to carry out appropriate personnel actions following a report of suspected  
14 child abuse or neglect alleged to have been committed by an employee of the facility or  
15 agency and involving a child who is currently or was previously under the care of that  
16 facility or agency;

17 (ix) the Juvenile Justice Monitoring Unit of the Office of the  
18 [Attorney General] **CORRECTIONAL OMBUDSMAN** established under [Title 6, Subtitle 4]  
19 **TITLE 9, SUBTITLE 4** of the State Government Article;

20 (x) subject to subsection (d) of this section, a licensed practitioner of  
21 a hospital or birthing center to make discharge decisions concerning a child, when the  
22 practitioner suspects that the child may be in danger after discharge based on the  
23 practitioner's observation of the behavior of the child's parents or immediate family  
24 members; or

25 (xi) the president of a Maryland public institution of higher  
26 education, as defined in § 10–101 of the Education Article, or the Chancellor of the  
27 University System of Maryland, to carry out appropriate personnel or administrative  
28 actions following a report of child abuse committed:

29 1. by an employee of the institution who has on-campus  
30 contact with children; or

31 2. by a contractor, an employee of a contractor, or a volunteer  
32 of the institution who has on-campus contact with children; and

33 (2) may be disclosed by the Department of Human Services to:

34 (I) the operator of a child care center that is required to be licensed  
35 or to hold a letter of compliance under Title 9.5, Subtitle 4 of the Education Article or to a  
36 family child care provider who is required to be registered under Title 9.5, Subtitle 3 of the

1 Education Article, to determine the suitability of an individual for employment in the child  
2 care center or family child care home;

3 (II) THE ADMINISTRATOR OF A CHILD CARE CENTER OPERATED  
4 BY OR ON BEHALF OF A UNIT OF STATE OR LOCAL GOVERNMENT OR IN A  
5 STATE-OCCUPIED BUILDING UNDER TITLE 9.5, SUBTITLE 5 OF THE EDUCATION  
6 ARTICLE;

7 (III) THE COACH, TEAM ADMINISTRATOR, OR MANAGER OF A  
8 YOUTH SPORTS PROGRAM FOR RECREATIONAL ATHLETIC COMPETITION OR  
9 INSTRUCTION FOR PARTICIPANTS WHO ARE MINORS; AND

10 (IV) THE ADMINISTRATOR OR OTHER APPROPRIATE PERSONNEL  
11 OF ANY ORGANIZATION THAT PROVIDES ADULT SUPERVISION OR CARE AND  
12 CONTROL OF CHILDREN.

13 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
14 October 1, 2026.
