1 AN ACT concerning

2 **Motor Vehicles – Speed Monitoring Systems – Safety Corridors**
3 **(Vulnerable Road User Protection Act of 2026)**

4 FOR the purpose of authorizing the State Highway Administration to implement a program
5 of safety corridor speed monitoring systems for use in areas determined to be of high
6 risk to vulnerable road users; authorizing a local jurisdiction to use speed monitoring
7 systems in safety corridors under certain circumstances; and generally relating to
8 the use of speed monitoring systems in safety corridors.

31 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
32 That the Laws of Maryland read as follows:

35 Except as provided in § 4–402 of this subtitle, and subject to the venue provisions of
36 Title 6 of this article, the District Court has exclusive original civil jurisdiction in:

1 (13) A proceeding for a civil infraction under § 21–202.1, § 21–704.1, §

29 places a mobile or stationary speed monitoring system to or at a location where a speed

5 1. THE REAR OF A MOTOR VEHICLE;

6 2. AT LEAST TWO TIME-STAMPED IMAGES OF THE
7 MOTOR VEHICLE THAT INCLUDE THE SAME STATIONARY OBJECT NEAR THE MOTOR
8 VEHICLE; AND

9 3. ON AT LEAST ONE IMAGE OR PORTION OF TAPE, A
10 CLEAR AND LEGIBLE IDENTIFICATION OF THE ENTIRE REGISTRATION PLATE

15 (5) “SAFETY CORRIDOR SPEED MONITORING SYSTEM OPERATOR”
16 MEANS A REPRESENTATIVE OF THE STATE HIGHWAY ADMINISTRATION OR ITS
17 CONTRACTOR THAT OPERATES A SAFETY CORRIDOR SPEED MONITORING SYSTEM.

18 (6) (I) “VULNERABLE ROAD USER” MEANS AN INDIVIDUAL ON A
19 HIGHWAY WHO IS NOT TRAVELING IN A MOTOR VEHICLE.

20 (II) “VULNERABLE ROAD USER” INCLUDES PEDESTRIANS,
21 BICYCLISTS, OTHER CYCLISTS, PERSONS USING A PERSONAL CONVEYANCE OR A
22 MOBILITY DEVICE SUCH AS A WHEELCHAIR, AND PERSONS ON FOOT IN A HIGHWAY
23 WORK ZONE.

24 (B) (1) (I) A SAFETY CORRIDOR SPEED MONITORING SYSTEM THAT
25 MEETS THE REQUIREMENTS OF THIS SUBSECTION MAY BE AUTHORIZED BY THE
26 STATE HIGHWAY ADMINISTRATION AND USED BY THE STATE HIGHWAY
27 ADMINISTRATION OR ITS CONTRACTOR TO RECORD THE IMAGES OF MOTOR
28 VEHICLES TRAVELING ON A STATE HIGHWAY WITHIN A SAFETY CORRIDOR.

29 (II) THE STATE HIGHWAY ADMINISTRATION MAY ISSUE A
30 PERMIT AUTHORIZING A LOCAL JURISDICTION THAT OPERATES ITS OWN PROGRAM

1 OF SPEED MONITORING SYSTEMS OR WORK ZONE SPEED CONTROL SYSTEMS TO
2 PLACE, IN ACCORDANCE WITH § 21-809 OF THIS SUBTITLE, SAFETY CORRIDOR
3 SPEED MONITORING SYSTEMS ON STATE HIGHWAYS IN SAFETY CORRIDORS WITHIN
4 ITS JURISDICTION.

5 (2) (I) A SAFETY CORRIDOR SPEED MONITORING SYSTEM MAY BE
6 USED ONLY IF, IN ACCORDANCE WITH THE MARYLAND MANUAL ON UNIFORM
7 TRAFFIC CONTROL DEVICES, A CONSPICUOUS ROAD SIGN IS PLACED AT A
8 REASONABLE DISTANCE CONSISTENT WITH NATIONAL GUIDELINES BEFORE THE
9 SAFETY CORRIDOR ALERTING DRIVERS THAT A SPEED MONITORING SYSTEM MAY BE
10 IN OPERATION IN THE SAFETY CORRIDOR.

11 (II) A SAFETY CORRIDOR SPEED MONITORING SYSTEM
12 OPERATOR DOES NOT NEED TO BE PRESENT IN PERSON OR REMOTELY AT THE
13 SAFETY CORRIDOR WHEN A SAFETY CORRIDOR SPEED MONITORING SYSTEM IS IN
14 USE.

15 (III) A SAFETY CORRIDOR SPEED MONITORING SYSTEM MAY BE
16 A MOBILE UNIT OR A STATIONARY UNIT.

17 (3) A SAFETY CORRIDOR SPEED MONITORING SYSTEM MAY BE USED
18 ONLY TO RECORD THE IMAGES OF VEHICLES THAT ARE TRAVELING AT SPEEDS AT
19 LEAST 12 MILES PER HOUR ABOVE THE POSTED SPEED LIMIT.

20 (4) (I) A SAFETY CORRIDOR SPEED MONITORING SYSTEM SHALL
21 UNDERGO AN ANNUAL CALIBRATION CHECK PERFORMED BY AN INDEPENDENT
22 CALIBRATION LABORATORY.

23 (II) THE INDEPENDENT CALIBRATION LABORATORY SHALL
24 ISSUE A SIGNED CERTIFICATE OF CALIBRATION AFTER THE ANNUAL CALIBRATION
25 CHECK THAT:

26 1. SHALL BE KEPT ON FILE; AND
