AMENDMENTS TO SENATE BILL 552  
(First Reading File Bill)

AMENDMENT NO. 1

On page 3, in line 1, strike “MAY” and substitute “SHALL”; in the same line, strike “STATE” and substitute “ANNUAL”; and in line 2, after “APPROPRIATION” insert “OF \$500,000”.

On page 6, in lines 18 and 20, in each instance, after “AREA” insert “TO SERVE IN AN ADVISORY CAPACITY”.

On page 7, strike beginning with “ONE” in line 3 down through “(8)” in line 6; in line 6, after “MEMBER” insert “WITH EXPERTISE IN ECONOMIC DEVELOPMENT,”; in line 8, strike “(9)” and substitute “(8)”; in the same line, strike “MEMBER APPOINTED BY THE GOVERNOR” and substitute “PRINCE GEORGE’S COUNTY COUNCIL MEMBER WHO REPRESENTS THE TARGET AREA TO SERVE IN AN ADVISORY CAPACITY, APPOINTED BY THE CHAIR OF THE PRINCE GEORGE’S COUNTY COUNCIL”; in line 9, after “COUNTY” insert “ECONOMIC”; in lines 9, 11, and 13, strike “(10)”, “(11)”, and “(12)”, respectively, and substitute “(9)”, “(10)”, and “(11)”, respectively; after line 14, insert:

“(12) THE EXECUTIVE DIRECTOR OF THE DEPARTMENT OF PERMITTING, INSPECTIONS, AND ENFORCEMENT OF PRINCE GEORGE’S COUNTY;

“(13) THE MARYLAND–NATIONAL CAPITAL PARK AND PLANNING COMMISSION’S PRINCE GEORGE’S COUNTY PLANNING DIRECTOR;”;

in lines 15 and 17, strike “(13)” and “(14)”, respectively, and substitute “(14)” and “(15)”, respectively; in line 18, after the semicolon insert:

**“(16) ONE SUITLAND COMMUNITY MEMBER, APPOINTED BY THE COUNTY EXECUTIVE OF PRINCE GEORGE’S COUNTY;”;**

and in line 19, strike “(15)” and substitute “(17)”.

**AMENDMENT NO. 2**

On page 9, in line 27, after “FOR” insert “:

**1.**”;

and in line 28, after the semicolon insert “**AND**

**2. PROPERTY OWNED OR CONTROLLED BY THE REVENUE AUTHORITY OF PRINCE GEORGE’S COUNTY OR THE REDEVELOPMENT AUTHORITY OF PRINCE GEORGE’S COUNTY;”.**
