## A BILL ENTITLED

1 AN ACT concerning

2 **Primary and Secondary Educators – Licenses and Public Profiles – Notation of**  
3 **Veteran Status**

4 FOR the purpose of authorizing the Department of Education to establish a process to  
5 include a notation indicating veteran status on licenses and public profiles of primary  
6 and secondary educators; and generally relating to the licenses and public profiles of  
7 primary and secondary educators.

11 Annotated Code of Maryland

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
14 That the Laws of Maryland read as follows:

15 **Article – Education**

16 **6–101.2.**

17 **(A) THE DEPARTMENT MAY ESTABLISH A PROCESS TO INCLUDE A**  
18 **NOTATION INDICATING VETERAN STATUS ON A LICENSE OR PUBLIC PROFILE.**

19 **(B) IF THE DEPARTMENT ESTABLISHES THE PROCESS DESCRIBED IN**  
20 **SUBSECTION (A) OF THIS SECTION, AN APPLICATION FOR A LICENSE SHALL ALLOW**  
21 **AN APPLICANT TO:**

1           **(1) PRESENT A CERTIFICATION OF VETERAN STATUS OBTAINED**  
2 **FROM THE DEPARTMENT OF VETERANS AND MILITARY FAMILIES IN ACCORDANCE**  
3 **WITH § 9-905 OF THE STATE GOVERNMENT ARTICLE, A DD FORM 214, OR OTHER**  
4 **DOCUMENTATION ACCEPTABLE TO THE DEPARTMENT CERTIFYING VETERAN**  
5 **STATUS; AND**

6           **(2) INDICATE THAT THE APPLICANT CONSENTS TO:**

7                   **(i) HAVING A NOTATION ON THE APPLICANT'S LICENSE OR**  
8 **PUBLIC PROFILE INDICATING THAT THE APPLICANT IS A VETERAN; AND**

9                   **(ii) BEING CONTACTED BY APPROPRIATE EXECUTIVE BRANCH**  
10 **AGENCIES REGARDING THE APPLICANT'S ELIGIBILITY FOR STATE OR FEDERAL**  
11 **VETERANS BENEFITS.**

12           **(c) IF AN APPLICANT PRESENTS THE REQUIRED DOCUMENTATION AND**  
13 **CONSENTS IN ACCORDANCE WITH SUBSECTION (b) OF THIS SECTION, THE**  
14 **DEPARTMENT SHALL:**

15                   **(1) INCLUDE ON THE APPLICANT'S LICENSE OR PUBLIC PROFILE A**  
16 **NOTATION INDICATING THAT THE APPLICANT IS A VETERAN; AND**

17                   **(2) IN ACCORDANCE WITH §§ 4-304 THROUGH 4-325 OF THE**  
18 **GENERAL PROVISIONS ARTICLE AND ANY OTHER APPLICABLE LAW, AND ON**  
19 **REQUEST FROM AN EXECUTIVE BRANCH AGENCY, ELECTRONICALLY TRANSMIT TO**  
20 **THE EXECUTIVE BRANCH AGENCY APPROPRIATE INFORMATION ABOUT THE**  
21 **APPLICANT.**

22           **(d) THE DEPARTMENT MAY ADOPT REGULATIONS TO CARRY OUT THIS**  
23 **SECTION.**

24           SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
25 October 1, 2026.
