AMENDMENTS TO SENATE BILL 60
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 2, strike “**Fraud Prevention**” and substitute “**Workplace Fraud**”; strike beginning with “prohibiting” in line 4 down through “rates;” in line 11; in line 12, strike “the MFCA;”; strike beginning with “requiring” in line 16 down through “law;” in line 19; in line 19, strike “fraud prevention” and substitute “workplace fraud”; and in line 20, strike “debarment.”

On pages 1 and 2, strike in their entirety the lines beginning with line 21 on page 1 through line 2 on page 2, inclusive.

On page 2, in line 5, strike “3–908 through”; in the same line, strike “and”; in the same line, after “3–913” insert “, and 3–917”; and strike in their entirety lines 8 through 22, inclusive.

AMENDMENT NO. 2

On pages 2 through 4, strike in their entirety the lines beginning with line 30 on page 2 through line 20 on page 4, inclusive.

On page 4, in line 23, in each instance, strike the bracket; and in the same line, strike “**WITHIN 90 DAYS AFTER**”.

On page 5, in line 31, after “**CONTRACTOR**” insert “**OR SUBCONTRACTOR**”.

On pages 5 and 6, strike beginning with “**SUBCONTRACTOR,**” in line 34 on page 5 down through “**IN**” in line 1 on page 6 and substitute “**SUBCONTRACTOR WITH WHOM THE GENERAL CONTRACTOR OR SUBCONTRACTOR HAS**”.

On page 6, in lines 1 and 2, strike “WITH THE GENERAL CONTRACTOR” and substitute “, IF THE GENERAL CONTRACTOR OR SUBCONTRACTOR FAILS TO COMPLY WITH § 3-903.1 OR § 3-914 OF THIS SUBTITLE”.

On pages 6 through 8, strike in their entirety the lines beginning with line 3 on page 6 through line 15 on page 8, inclusive.

On page 8, in lines 32 and 33, strike “MEET AT LEAST MONTHLY TO”; and in line 33, after “INFORMATION” insert “AT LEAST MONTHLY”.

On page 9, in line 1, strike “, TITLE 8 OF THE GENERAL PROVISIONS ARTICLE,”; in line 10, strike the colon; in line 11, strike “(I)”; strike beginning with the semicolon in line 12 down through “MERIT” in line 16; after line 20, insert:

“(II) THE ATTORNEY GENERAL SHALL COMPLETE AN INVESTIGATION REFERRED UNDER PARAGRAPH (2) OF THIS SUBSECTION WITHIN 60 DAYS AFTER REFERRAL.”;

in line 21, strike “(II)” and substitute “(III)”; in line 24, strike the colon; in line 25, strike “1.”; and strike beginning with “; OR” in line 26 down through “SUBTITLE” in line 28.

On pages 10 through 14, strike in their entirety the lines beginning with line 1 on page 10 through line 4 on page 14, inclusive.

On page 14, after line 21, insert:

“3-917.

The Commissioner shall:

(1) DEVELOP A FORM THAT GENERAL CONTRACTORS MAY USE AS EVIDENCE OF COMPLIANCE WITH §§ 9-301.1 AND 9-314 OF THIS ARTICLE;

(2) PROVIDE TRAINING TO A GENERAL CONTRACTOR OR SUBCONTRACTOR FOUND LIABLE FOR AN UNKNOWING VIOLATION OF THIS SUBTITLE; AND

(3) adopt regulations to carry out this subtitle.”.

On pages 14 through 22, strike in their entirety the lines beginning with line 23 on page 14 through line 5 on page 22, inclusive.

On page 22, in lines 8 and 9, strike “MEET AT LEAST MONTHLY TO”; in line 9, after “INFORMATION” insert “AT LEAST MONTHLY”; in line 10, strike “TITLE 8 OF THE GENERAL PROVISIONS ARTICLE,”; in line 17, strike “SHALL” and substitute “MAY”; and in lines 19 and 20, strike “AND WAS NOT OTHERWISE REQUIRED TO INVESTIGATE UNDER § 18-107(A) OF THIS TITLE”.
