2 **Sales and Use Tax – Certificates Indicating Multiple Points of Use – Alterations**

3 FOR the purpose of ~~providing that~~ authorizing, for purposes of certain laws governing the  
4 sales and use tax, a buyer to issue a certain certificate indicating multiple points of  
5 use of certain digital codes, digital products, or taxable services shall be deemed fully  
6 completed under certain circumstances and subject to certain limitations; providing  
7 ~~that a buyer is not required to obtain prior approval from the Comptroller before~~  
8 ~~presenting a certificate indicating multiple points of use to a vendor; requiring the~~  
9 ~~Comptroller to relieve a vendor of the obligation to collect, pay, or remit certain sales~~  
10 ~~and use tax under certain circumstances; providing that a certificate indicating~~  
11 ~~multiple points of use shall remain in effect for certain future sales except under~~  
12 ~~certain circumstances; requiring the Comptroller to publish a certain form for a~~  
13 ~~certificate indicating multiple points of use in a certain manner; applying this Act~~  
14 ~~retroactively; providing for the application for and denial, renewal, and revocation of~~  
15 an authorization for a buyer to issue multiple points of use certificates; providing for  
16 the validity and rescission of multiple points of use certificates; requiring an  
17 authorized buyer to provide and a vendor to verify a multiple points of use certificate  
18 in a certain manner; and generally relating to the sales and use tax and certificates  
19 indicating multiple points of use.

16 (2) “Affiliated group” has the meaning stated under § 1504 of the Internal  
 17 Revenue Code and includes related parties described under § 267(b)(10), (11), or (12) of the  
 18 Internal Revenue Code.

19 **(3) “AUTHORIZED BUYER” MEANS A BUYER AUTHORIZED BY THE**  
 20 **COMPTROLLER TO ISSUE TO A VENDOR A MULTIPLE POINTS OF USE CERTIFICATE.**

21 ~~(3)~~ **(4)** “Pass-through entity” has the meaning stated in § 10-102.1 of  
 22 this article.

23 ~~(4)~~ **(5)** “Related pass-through entities” means one or more  
 24 pass-through entities connected through ownership with a common parent pass-through  
 25 entity but only if the common parent:

26 (i) possesses at least 80% of the total voting power of the  
 27 pass-through entity; and

28 (ii) has a value equal to at least 80% of the total value of the  
 29 pass-through entity.

30 ~~(5)~~ **(6)** “Sales” includes a booking transaction made through a  
 31 short-term rental platform.

1           **(E) (1) SUBJECT TO THE LIMITATIONS OF THIS SECTION, A BUYER MAY**  
2 **ISSUE A MULTIPLE POINTS OF USE CERTIFICATE IF:**

3                   **(I) THE BUYER REGISTERS WITH THE COMPTROLLER FOR A**  
4 **SALES AND USE TAX ACCOUNT;**

5                   **(II) FOLLOWING REGISTRATION IN ACCORDANCE WITH ITEM (I)**  
6 **OF THIS PARAGRAPH, THE BUYER REQUESTS AND OBTAINS AUTHORIZATION FROM**  
7 **THE COMPTROLLER TO ISSUE A MULTIPLE POINTS OF USE CERTIFICATE; AND**

8                   **(III) THE BUYER HAS PAID ALL UNDISPUTED TAXES PAYABLE TO**  
9 **THE COMPTROLLER OR PROVIDED FOR PAYMENT IN A MANNER SATISFACTORY TO**  
10 **THE UNIT RESPONSIBLE FOR COLLECTION OF THE TAX.**

11           **(2) AN AUTHORIZATION TO ISSUE A MULTIPLE POINTS OF USE**  
12 **CERTIFICATE SHALL BE VALID FOR A PERIOD NOT LESS THAN 2 YEARS UNLESS**  
13 **SUSPENDED OR REVOKED BY THE COMPTROLLER UNDER PARAGRAPH (5) OF THIS**  
14 **SUBSECTION.**

15           **(3) A BUYER MAY APPLY TO THE COMPTROLLER FOR A RENEWAL OF**  
16 **THE AUTHORIZATION TO ISSUE A MULTIPLE POINTS OF USE CERTIFICATE NOT MORE**  
17 **THAN 90 DAYS BEFORE THE EXPIRATION OF THE CURRENT AUTHORIZATION.**

18           **(4) THE COMPTROLLER MAY DENY A BUYER'S REQUEST FOR**  
19 **AUTHORIZATION OR RENEWAL OF AN AUTHORIZATION TO ISSUE A MULTIPLE POINTS**  
20 **OF USE CERTIFICATE DUE TO THE BUYER'S FRAUD, GROSS NEGLIGENCE, MISUSE OF**  
21 **A MULTIPLE POINTS OF USE CERTIFICATE, DELINQUENCY IN THE PAYMENT OF**  
22 **UNDISPUTED SALES AND USE TAX, OR OTHER SIMILAR REASONABLE CAUSE.**

23           **(5) (I) ON WRITTEN NOTICE TO A BUYER, THE COMPTROLLER MAY**  
24 **REVOKE THE BUYER'S AUTHORIZATION TO ISSUE A MULTIPLE POINTS OF USE**  
25 **CERTIFICATE DUE TO THE BUYER'S FRAUD, GROSS NEGLIGENCE, MISUSE OF A**  
26 **MULTIPLE POINTS OF USE CERTIFICATE, DELINQUENCY IN THE PAYMENT OF**  
27 **UNDISPUTED SALES AND USE TAX, OR OTHER SIMILAR REASONABLE CAUSE.**

28                   **(II) FOLLOWING REVOCATION OF A BUYER'S AUTHORIZATION**  
29 **TO ISSUE A MULTIPLE POINTS OF USE CERTIFICATE, ANY MULTIPLE POINTS OF USE**  
30 **CERTIFICATE ISSUED BY THE BUYER TO VENDORS SHALL BE VOID FROM THE DATE**  
31 **THAT THE COMPTROLLER ISSUES THE NOTICE UNDER PARAGRAPH (7) OF THIS**  
32 **SUBSECTION.**

33           **(6) IF THE COMPTROLLER REVOKES A BUYER'S AUTHORIZATION IN**  
34 **ACCORDANCE WITH PARAGRAPH (5) OF THIS SUBSECTION, THE BUYER SHALL**

1 PROVIDE THE COMPTROLLER A LIST OF ALL VENDORS TO WHICH THE BUYER ISSUED  
 2 MULTIPLE POINTS OF USE CERTIFICATES.

3 (7) (I) NOTWITHSTANDING ANY OTHER PROVISION OF LAW, THE  
 4 COMPTROLLER SHALL PROVIDE WRITTEN NOTIFICATION TO EACH VENDOR THAT  
 5 HAS RECEIVED A MULTIPLE POINTS OF USE CERTIFICATE FROM A BUYER WHOSE  
 6 AUTHORITY TO ISSUE A MULTIPLE POINTS OF USE CERTIFICATE HAS BEEN  
 7 REVOKED.

8 (II) THE NOTICE REQUIRED UNDER SUBPARAGRAPH (I) OF THIS  
 9 PARAGRAPH SHALL ADVISE THE VENDOR OF THE DATE ON WHICH A MULTIPLE  
 10 POINTS OF USE CERTIFICATE HAS BEEN VOIDED.

26 PROPER MULTIPLE POINTS OF USE CERTIFICATE, WITHIN 60 DAYS AFTER THE DATE  
27 ON WHICH THE NOTICE IS MAILED.
