A BILL ENTITLED

1 AN ACT concerning

2 **Financial Institutions – Payment Stablecoin Services – Establishment and**
3 **Regulation**
4 **(Maryland Stablecoin Act)**

5 FOR the purpose of altering the examination fee for a new commercial bank charter;
6 requiring a certain nondepository trust company to include certain disclosures in its
7 articles of incorporation; exempting from certain provisions of law a certain
8 nondepository trust company authorized to provide certain services by the
9 Commissioner of Financial Regulation; authorizing a certain nondepository trust
10 company to request that the Commissioner reduce the capital stock requirements
11 under certain circumstances; establishing a regulatory and legal framework for
12 entities in the State to serve as State issuers of stablecoin–related services or as
13 payment stablecoin services institutions; and generally relating to payment
14 stablecoin services in the State.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

22 latest federal or State census.

23 (e) “Nondepository trust company” means a trust company that is not insured by
24 the Federal Deposit Insurance Corporation.

19 (c) The articles of incorporation may include:

20 (1) Any provision that requires for any purpose the concurrence of a greater
21 proportion of the votes of all classes or of any class of capital stock than the proportion
22 required by this article for that purpose; and

23 (2) Any provision that defines, limits, or denies the preemptive rights of
24 stockholders to acquire additional stock of the State bank or trust company.

26 (a) Except as otherwise provided in this article, a commercial bank has all of the
27 general powers granted to Maryland corporations under the Maryland General Corporation
28 Law.

29 (b) In addition to the powers set forth elsewhere in this article, a commercial bank
30 may:

- 1 (1) Receive deposits of money on which interest may be paid;
- 2 (2) Buy and sell coin and bullion;
- 3 (3) Buy and sell foreign and domestic exchange;
- 4 (4) Subject to § 3–604 of this title, accept drafts drawn on it;
- 5 (5) Issue letters of credit that authorize the holder to draw drafts on it or
6 on its correspondents payable at sight or at a time not exceeding 1 year;
- 7 (6) Issue its debt instruments for money that is borrowed or received on
8 deposit or for investment;
- 9 (7) Lend money on personal security or on real or personal property;
- 10 (8) Subject to § 3–605 of this title, become owner and lessor of personal
11 property;
- 12 (9) Subject to § 5–503 of this article, buy, hold, lease, and convey real
13 property;
- 14 (10) Pledge collateral to secure deposits of:
 - 15 (i) The federal government or its agencies; or
 - 16 (ii) Any state or its political subdivisions;
- 17 (11) Pledge securities to secure the money of an estate administered under
18 the federal bankruptcy laws;
- 19 (12) Without being deemed a branch of a depository institution affiliate, act
20 in accordance with § 101(d) of the Riegle–Neal Interstate Banking and Branching
21 Efficiency Act of 1994, as agent of any depository institution affiliate in:
 - 22 (i) Receiving deposits;
 - 23 (ii) Renewing time deposits;
 - 24 (iii) Closing loans;
 - 25 (iv) Servicing loans; or
 - 26 (v) Receiving payments on loans and other obligations; and
- 27 (13) Exercise all of the powers usual in carrying on a banking business.

1 **(C) (1) IN THIS SUBSECTION, “APPROPRIATE FEDERAL BANKING**
2 **AGENCY” HAS THE MEANING STATED IN THE FEDERAL DEPOSIT INSURANCE ACT.**

17 **(A) THIS SECTION DOES NOT APPLY TO A NONDEPOSITORY TRUST COMPANY**
18 **AUTHORIZED BY THE COMMISSIONER IN ACCORDANCE WITH TITLE 14 OF THIS**
19 **ARTICLE TO ENGAGE IN BUSINESS AS:**

20 **(1) A STATE ISSUER; OR**

21 **(2) A PAYMENT STABLECOIN SERVICES INSTITUTION.**

22 **(B) In addition to the powers set forth elsewhere in this article, a trust company**
23 **may:**

24 (1) Receive deposits of money, securities, and other personal property from
25 any person;

26 (2) Act as the agent of any foreign or Maryland corporation for any lawful
27 purpose;

28 (3) Act as the fiscal or transfer agent of any state, any political subdivision
29 of any state, or any corporation;

1 (4) Accept and execute any trust and any powers that are conferred on or
2 entrusted to it in any manner, including any grant, assignment, transfer, devise, or bequest
3 by any person or by order of a court;

4 (5) Accept and hold trust property;

5 (6) Act as trustee under a mortgage or bond issue of a corporation or
6 political subdivision;

7 (7) Act as personal representative of the estate of any deceased individual;
8 and

9 (8) Act as guardian, receiver, or trustee of the estate of any person under
10 order or appointment of a court and as depository of money paid to the court for the benefit
11 of the person.

13 (a) (1) Before the Commissioner issues a certificate to do business, the
14 required capital stock and the required surplus shall be paid in full.

15 (2) **[A] EXCEPT AS PROVIDED IN SUBSECTION (D) OF THIS SECTION, A**
16 commercial bank shall have required capital stock that equals at least:

17 (i) \$750,000, if it is in a municipal area with not more than 50,000
18 inhabitants; and

19 (ii) \$1.5 million, if it is in a municipal area with more than 50,000
20 inhabitants.

21 (3) A commercial bank shall have a surplus in an amount that equals at
22 least 20 percent of its required capital stock.

23 (b) (1) Before a commercial bank establishes a branch, the commercial bank
24 shall have capital stock and surplus as provided in this subsection.

25 (2) For a branch that is to be located inside the municipal area of the
26 principal banking office of the commercial bank, the commercial bank shall have capital
27 stock and surplus that equal at least the sum of the amounts required by subsection (a) of
28 this section.

29 (3) For a branch that is to be located outside the municipal area of the
30 principal banking office of the commercial bank, the commercial bank shall have capital
31 stock and surplus that equal at least the sum of:

32 (i) The amount required by subsection (a) of this section; and

- 1 (ii) 1. \$120,000, if it is in a municipal area with not more than
- 2 25,000 inhabitants;
- 3 2. \$180,000, if it is in a municipal area with more than 25,000
- 4 and not more than 100,000 inhabitants;
- 5 3. \$240,000, if it is in a municipal area with more than
- 6 100,000 and not more than 250,000 inhabitants; and
- 7 4. \$900,000, if it is in a municipal area with more than
- 8 250,000 inhabitants.

9 (c) Unless otherwise provided by law, the unimpaired capital and surplus of a
 10 commercial bank include its debt instruments issued under § 3–312 of this title.

11 **(D) (1) (I) A NONDEPOSITORY TRUST COMPANY MAY REQUEST THAT**
 12 **THE COMMISSIONER REDUCE THE CAPITAL STOCK REQUIREMENTS FOR THAT**
 13 **NONDEPOSITORY TRUST COMPANY.**

14 **(II) INCORPORATORS SEEKING TO FORM A NONDEPOSITORY**
 15 **TRUST COMPANY MAY MAKE A REQUEST IN ACCORDANCE WITH THIS PARAGRAPH**
 16 **PRIOR TO FILING ARTICLES OF INCORPORATION.**

17 **(III) A NONDEPOSITORY TRUST COMPANY MAKING A REQUEST**
 18 **UNDER THIS PARAGRAPH SHALL PROVIDE THE COMMISSIONER WITH ALL**
 19 **INFORMATION THAT THE COMMISSIONER REQUIRES.**

28 (b) (1) A nondepository trust company shall pledge securities or deliver a
 29 surety bond to the Commissioner, for the benefit of the Commissioner, to defray the costs
 30 of a receivership.

31 **(2) (I) THIS PARAGRAPH DOES NOT APPLY TO A NONDEPOSITORY**
 32 **TRUST COMPANY THAT ENGAGES IN BUSINESS UNDER TITLE 14 OF THIS ARTICLE.**

1 **(II)** The amount of the securities or surety bond shall be determined
2 by the Commissioner in an amount that the Commissioner deems appropriate to defray
3 such costs, but in no event shall the amount exceed:

4 **[(i)] 1.** \$1,000,000 for a nondepository trust company with a
5 composite rating, using the Uniform Interagency Trust Rating System, of 1 or 2; or

6 **[(ii)] 2.** \$3,000,000 for a nondepository trust company with a
7 composite rating, using the Uniform Interagency Trust Rating System, of 3, 4, or 5.

9 (c) (1) Except as provided in [paragraph] **PARAGRAPHS (2) AND (4)** of this
10 subsection, the Commissioner shall assess each banking institution the sum of:

11 (i) \$8,000; plus

12 (ii) 1. 12 cents for each \$1,000 of the assets of the institution over
13 \$50,000,000, but not more than \$250,000,000;

14 2. 10 cents for each \$1,000 of assets over \$250,000,000, but
15 not more than \$500,000,000;

16 3. 9 cents for each \$1,000 of assets over \$500,000,000, but not
17 more than \$1,000,000,000;

18 4. 8 cents for each \$1,000 of assets over \$1,000,000,000, but
19 not more than \$10,000,000,000; and

20 5. 7 cents for each \$1,000 of assets over \$10,000,000,000.

21 (2) If a banking institution is not in the business of accepting deposits or
22 retaining funds in a deposit account as defined in § 5–509 of this title, the Commissioner
23 shall assess the banking institution the sum of:

24 (i) \$5,000; plus

25 (ii) 1. 0.3 cents for each \$1,000 of managed assets held in a
26 fiduciary capacity up to \$5,000,000,000;

27 2. 0.2 cents for each \$1,000 of managed assets held in a
28 fiduciary capacity over \$5,000,000,000, but not more than \$20,000,000,000;

29 3. 0.1 cent for each \$1,000 of managed assets held in a
30 fiduciary capacity over \$20,000,000,000 up to \$27,500,000,000;

1 4. 0.2 cents for each \$1,000 of nonmanaged and custodial
2 assets held in a fiduciary capacity up to \$5,000,000,000; and

3 5. 0.1 cent for each \$1,000 of nonmanaged and custodial
4 assets held in a fiduciary capacity over \$5,000,000,000 up to \$20,000,000,000.

5 (3) The assessments shall be based on assets stated in a banking
6 institution's most recent financial report.

7 **(4) THE COMMISSIONER SHALL DETERMINE THE ASSESSMENTS FOR**
8 **BANKING INSTITUTIONS ENGAGING IN BUSINESS UNDER TITLE 14 OF THIS ARTICLE**
9 **BY REGULATION.**

11 (a) In this title the following words have the meanings indicated.

12 (b) “Board” means the board of directors of a credit union.

13 (c) (1) “Branch” means a credit union office at which shares or deposits are
14 received, share drafts or checks are paid, or money is lent.

15 (2) “Branch” includes a mobile branch or other special–purpose facility that
16 performs a function of a branch.

17 (3) “Branch” does not include an automated teller machine as defined in §
18 1–401(d) of this article.

19 (d) “Credit union” means a cooperative, nonprofit financial institution organized
20 under this title to conduct business in the State.

21 (e) “Credit union service organization” means an entity formed to engage in
22 activities that:

23 (1) Are incidental to the conduct of the business of a credit union;

24 (2) Advance or facilitate the purposes of a credit union; and

25 (3) Primarily serve a credit union and its members.

26 (f) (1) “Credit union share guaranty corporation” means a corporation
27 engaged in the business of guaranteeing or insuring payment of a credit union share or
28 deposit account.

29 (2) “Credit union share guaranty corporation” includes the Credit Union
30 Insurance Corporation established under Title 7 of this article.

1 (g) “Deposit account” means a balance held by a credit union on which a
2 contractual rate of interest may be paid as a debt owed by the credit union to the depositor.

3 (h) “Fixed assets” includes land, buildings, leasehold improvements, furniture,
4 fixtures, and equipment used in the conduct of the regular business of a credit union.

5 (i) “Member in good standing” means a member who:

6 (1) Owns at least one share in a credit union;

7 (2) Is current on all credit obligations to the credit union; and

8 (3) Has not caused the credit union a credit or deposit loss that is currently
9 outstanding.

10 (j) “Officer” means any officer that a Maryland corporation is required or
11 permitted to have under § 2–412 of the Corporations and Associations Article.

12 (k) “Official” means:

13 (1) A director;

14 (2) A member of a credit committee; or

15 (3) A member of a supervisory committee.

16 (l) “Out-of-state credit union” means:

17 (1) A federal credit union with its main office in a state other than this
18 State; or

19 (2) A credit union chartered and primarily regulated by another state.

20 **(M) “PAYMENT STABLECOIN-RELATED SERVICES” HAS THE MEANING**
21 **STATED IN § 14–101 OF THIS ARTICLE.**

22 **(N) “PAYMENT STABLECOIN SERVICES INSTITUTION” HAS THE MEANING**
23 **STATED IN § 14–101 OF THIS ARTICLE.**

24 **(O) “PERMITTED PAYMENT STABLECOIN ISSUER” HAS THE MEANING**
25 **STATED IN § 14–101 OF THIS ARTICLE.**

26 [(m)] **(P) “Share” or “share account” means a balance held by a credit union on**
27 **which a dividend may be paid and which confers membership and voting rights on the**
28 **member.**

2 (A) In addition to the powers set forth elsewhere in this title, a credit union may:

3 (1) Receive the shares and deposits of its members;

4 (2) Lend money to its members;

5 (3) Invest funds as provided in this title; and

6 (4) Undertake other activities that:

7 (i) Are consistent with this title;

8 (ii) Relate to its purposes; and

9 (iii) Are authorized by its bylaws.

25 SUBTITLE 1. GENERAL PROVISIONS.

26 14-101.

27 (A) IN THIS TITLE THE FOLLOWING WORDS HAVE THE MEANINGS
28 INDICATED.

1 (B) "APPLICANT" MEANS A NONDEPOSITORY TRUST COMPANY OR A CREDIT
2 UNION SERVICE ORGANIZATION THAT APPLIES TO THE COMMISSIONER FOR
3 AUTHORITY TO ENGAGE IN BUSINESS UNDER THIS TITLE.

4 (C) "BOARD" HAS THE MEANING STATED IN THE FEDERAL GENIUS ACT OF
5 2025.

6 (D) "CERTIFICATE" MEANS A CERTIFICATE ISSUED BY THE COMMISSIONER
7 TO AN APPLICANT IN ACCORDANCE WITH § 14-307 OF THIS TITLE.

8 (E) "CERTIFICATE HOLDER" MEANS A NONDEPOSITORY TRUST COMPANY
9 OR A CREDIT UNION SERVICE ORGANIZATION ISSUED A CERTIFICATE UNDER THIS
10 TITLE.

11 (F) "CONSUMER" MEANS AN INDIVIDUAL WHO ENTERS INTO A
12 TRANSACTION FOR PERSONAL, FAMILY, OR HOUSEHOLD PURPOSES.
